ORDER

WHEREAS, in terms of Section 15(3)(a) of the NCTE Act, 1993, the recognition was granted to Radhanath Institute of Advanced Studies in Education, PO-Chandni Chowk, Cuttack, Odisha-753002 for conducting M.Ed. programme of one year duration with an annual intake of 24 students *vide* Order No. F.7-13/2000-ERC/846 dated 06.04.2000 from the academic session 2000-2001, followed by revised recognition order for M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016 *vide* Order No. ER-189.12.1.1/M.Ed./(Revised Order)/2015/32693 dated 31.05.2015, as per NCTE Regulations, 2014.

- **2. AND WHEREAS**, recognition of the institution was withdrawn *vide* Order No. F.No.ER-278.42/OR-SO/E-3/99/M.Ed./2020/62148 dated 28.01.2020.
- **3. AND WHEREAS**, F.No.-89-200/E-262950/2022 Appeal/1st Meeting, 2023/APPLERC 202214403/117159 dated 09.02.2023, the Committee decided as under:
 - "Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verity the submitted documents from the concerned issuing authorities."
- **4. AND WHEREAS**, representation dated 15.02.2023 received in ERC office on dated 17.04.2023. The matter was considered by the ERC in its 325th (Virtual) meeting of the ERC held on 24.04.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No. F.No.-89-200/E-262950/2022 Appeal/1st Meeting, 2023/APPLERC202214403/ 117159 dated 09.02.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

• The Committee noted that the withdrawal order 28.01.2020 has already been set aside by the Appellate Authority vide its Order dated 09.02.2023 and remanded back to ERC for

consideration, therefore, ERC decided that the recognition granted to the institution for running M.Ed. programme is hereby restored.

Order be issued accordingly."

5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Radhanath Institute of Advanced Studies in Education, PO-Chandni Chowk, Cuttack, Odisha-753002 vide Order No. ER-189.12.1.1/M.Ed./(Revised Order)/2015/32693 dated 31.05.2015 for M.Ed. programme with an annual intake of 50 students (one basic unit) is hereby restored subject to fulfilment of the NCTE Regulation, 2014 until a fresh withdrawal order is issued by ERC.
