ORDER

WHEREAS, St. Xavier's College, P.B. No. 9, Purulia Raod, Ranchi, Jharkhand-834001 (Code No.APE00244) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2005-2006 vide ERC Order dated 29.10.2004, followed by revised recognition order issued on 31.05.2015 with an intake of 100 (Two basic unit) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS**, the ERC in its 274^{th} meeting held on $15^{th} 16^{th}$ July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61579 dated 11.09.2019 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.03.2020. The Appellate Authority vide order No. 89-460/E-142176/2019/Appeal/2nd Mtg.-2020/30th January,2020/89806 remanded back the case to ERC with a direction to consider the documents, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of order on the appeal.
- 4. **AND WHEREAS**, the institution submitted reply dated 06.03.2020 received in this office 12.03.2020. The ERC in its 282^{nd} Meeting held on $8^{th} 9^{th}$ July, 2020 and decided, show cause Notice u/s 17 (1) was issued on 24.07.2020 to the institution on the following grounds:
 - a) As per Building Completion Certificate (BCC), total land area & built up area is 9200 Sq. ft., which is not sufficient to run two units of B.Ed. Course as per Regulations 2014/ Norms & Standards.
 - b) Built up area of the institution should be earmarked for the existing Teacher Education Course in the Building Plan (BP)
- 5. AND WHEREAS, institution submitted reply vide letter dated 28.07.2020 and received in this office on 11.08.2020 in response to SCN dated 24.07.2020. The Original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 283rd meeting held on 24th & 25th August, 2020 and the committee decided as under:-
 - > Restoration of Recognition Order of B.Ed. course to be issued.
