### ORDER

WHEREAS, Lakhimpur Post Graduate Training College, North Lakhimpur, Lakhimpur, Assam- 787001 (Code No. AS-S/E-8/96) was granted recognition for conducting B.Ed. course of one year duration with an intake of 60 students from the academic session 1997-1998 vide ERC's order No. 2802(ii) dated 12.02.1997.

- 2. **AND WHEREAS,** Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 50 students from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/AS-S/E-8/96 & APE00200/B.Ed.(Revised Order)/2015/32563 dated 31.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS,** the ERC in its  $261^{st}$  meeting held on  $24^{th} 25^{th}$  September, 2018 considered the matter and decided,  $1^{st}$  Show Cause Notice was issued on 08.10.2018 to the institution on the following grounds:-
  - (i) FDRs validity has been expired since 20.11.2014 & 11.09.2018, which needs to be resubmitted with a quantum of Rs.12 lakhs (Rs.7 lakhs + Rs.5 lakhs) towards Endowment and Reserve fund as per NCTE Regulations, 2014.
  - (ii) Building plan and building completion certificate duly approved by Govt. Engineer not submitted.
  - (iii) Approved faculty list by the concerned affiliating body is to be submitted as per NCTE Regulations, 2014.
- 4. **AND WHEREAS**, the institution submitted reply vide letter dated 26.10.2018 & 29.10.2018, received in ERC, NCTE on 31.10.2018 & 09.11.2018 respectively. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020 considered the matter and decided, Final Show Cause Notice was issued on 26.02.2020 to the institution on the following grounds:-
  - (i) Certified copy of registered land document to be submitted.
  - (ii) List of teaching faculty mentioned in Sl.No.9, 16 & 17 are not eligible.
  - (iii) Building Plan (BP) indicating the Plot No./Khata No., total land area and total built up area etc. duly approved by competent Govt. Engineer is not submitted.
  - (iv) Building Completion Certificate (BCC) in the prescribed proforma is not submitted.
  - (v) Original FDRs of Rs. 5 lakh and Rs. 7 lakh to be submitted.
  - (vi) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.

- (vii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 5. **AND WHEREAS**, the institution submitted reply vide letter dated 18.03.2020, received in ERC, NCTE on 08.05.2020. The ERC in its  $283^{rd}$  meeting held on  $24^{th} 25^{th}$  August, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and observed as under:-
  - (i) Teaching faculty mentioned at sl. No.2, 3, 4, 5 and 7 do not possess requisite percentage of marks as per Appendix-4 of Regulation2014/Norms & Standards.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

- 6. NOW THEREFORE, recognition granted to the institution viz. Lakhimpur Post Graduate Training College, North Lakhimpur, Lakhimpur, Assam- 787001 (Code No. AS-S/E-8/96) for B.Ed. Course of two year duration with an annual intake of 50 students is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022.
- 7. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <a href="https://www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of the issue of the order.
