ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993 **Dr. Parsuram Mishra Institute of Advanced Studies in Education, Dist.-Sambalpur, Orissa- 751007 (Code No. OR-SO/N-4/2000)** was granted recognition for conducting M.Ed. course of one year duration with annual intake of 24 from the academic session 2001-2002 vide ERC's order F.No. ERC/7-19/2001/1660 dated 15.06.2001, followed by Revised Recognition for M.Ed. programme of two year duration with an annual intake of 50 students (One Basic Unit) from the academic session 2015-2016 vide order ER-189.12.1.2/M.Ed.(Revised Order)/2015/32701 dated 31.05.2015 as per NCTE Regulation, 2014.

2. AND WHEREAS, as per the decision of ERC in its 254th meeting held on 16" - 17th April, 2018 First Show Cause Notice to the institution on certain grounds.

3. AND WHEREAS, the institution submitted reply vide letter dated Nil, received in ERC, NCTE on 16.05.2019. The ERC in its 272d meeting held on 30th - 31* May & 1" June, 2019 considered the matter and as per the decision of ERC, Final Show Cause Notice was issued on 18.06.2019 to the institution on certain grounds.

4. AND WHEREAS, the institution submitted reply vide letter dated Nil, received in ERC, NCTE on 27.12.2019. The ERC in its 278" meeting held on 16" - 18" January, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-

(i) Faculty list is not duly approved by the concerned affiliating body. Teaching faculty comprises I+8 as against the requirement of I+9 for running one unit of M.Ed. course as per NCTE Regulation, 2014. Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

5. AND WHEREAS, in terms of above decision of ERC, the recognition of the institution was withdrawn vide Order dated 28.01.2020.

6. AND WHEREAS, the institution has preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 28.01.2020 and the Appellate Authority passed order dated 01.04.2024, set aside the withdrawal order of ERC and remanded back the case to ERC with a direction to verify the faculty list submitted in appeal. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above..

7. **AND WHEREAS**, the institution has submitted documents reply dated 03.04.2024. The matter was placed in 343rd meeting of ERC held on 09.05.2024 and the Committee decided as under:

"The original file of the institution alongwith Appeal Order No. File No.89-148E-257180/2022 Appeal/4th Meeting, 2024 APPLERC202214381 Date 01.04.2024, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC. The ERC decided the following :-

- *The Committee noted that the withdrawal order dated 28.01.2020 has already been set aside by the Appellate Authority and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running M.Ed. programmewith an annual intake of 50 (One Unit) is restored until a fresh withdrawal order is issued by ERC. Order be issued accordingly.*

The Committee further decided the following :-

- *Issue First SCN u/s 17 of NCTE Act 1993 to the institution on the following grounds :-*
- *Appointed Principal is not qualified*
- *One Professor (Prof. Dibakar Sarangi) is not qualified*
- *The institution be directed to submit the course wise staff list duly approved by the affiliating University".*

8. **NOW THEREFORE**, in terms of above decision of ERC, the said recognition granted to the institution viz. **Dr. Parsuram Mishra Institute of Advanced Study in Education, Sambalpur, Odisha-768001** vide Order F.No. ERC/7-19/2001/1660 dated 15.06.2001, followed by Revised Recognition for M.Ed. programme of two year duration with an annual intake of 50 students (One Basic Unit) from the academic session 2015-2016 vide order ER-189.12.1.2/M.Ed.(Revised Order)/2015/32701 dated 31.05.2015 is hereby restored until a fresh withdrawal order is issued by ERC.
