College, Lanka, Nagaon, Assam–782 446 was granted recognition for B.Ed. course with an intake of 100 from the academic session 2004-2005 vide order dated 08.12.2004, followed by revised order dated 22.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th, 31st May & 01st June'2019 considered the matter along with the reply dated 11.05.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - i. Show Cause Notice u/s 17(1) were issued on 28.11.2018, 17.01.2019 & 14.05.2019.
 - ii. Faculties (Art Education and Physical Education) mentioned at sl. No.15 & 16 of the approved list have been appointed after 09.06.2017 who do not possess requisite NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.

In view of the above, the Committee decided as under:-

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing Code No.APE00212 is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to Krishna Bora B.Ed. College, Lanka, Nagaon, Assam-782 446 (Code No. APE00212) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
