ORDER

WHEREAS, Parijat Academy Teacher Education Institution, Milan Nagar, 'O' Lane, Dibrugarh, Assam-786003 (APE00298) was granted recognition for B.Ed. course with an intake of 100 vide ERC order No. ERC/7-62.6.3/2005/1452 dated 23.11.2005, followed by revised recognition order from the academic session 2015-2016 with an intake of 100 (two basic units) vide dated 20.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS,** the ERC in its 254^{th} meeting held on $16^{th} 17^{th}$ April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. **AND WHEREAS**, the institution has submitted reply dt. 04.05.2018 & 19.06.2019 in response to show cause **not**ice issued by ERC letter dated 20.04.2018. The ERC in its 275^{th} Meeting held on $26^{th} 27^{th}$ July, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 28.08.2019 on the following grounds:-
 - Faculty list comprises 1+6 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course. Part-time faculties are not accepted.
 - b. Total built up area mentioned in the building plan as 1230.8 sq. Mts. which is less than required 2000 Sq. Mts. for running 100 intake of B.Ed. course.
 - c. Original FDRs Rs.5 lakh and Rs.7 lakh are not in joint mode.
 - d. Website not uploaded.
 - e. Building completion certificate is not issued by competent Govt. Engineer.
- 4. **AND WHEREAS**, the institution has submitted reply dt. 11.09.2019 in response to show cause notice issued by ERC letter dated 28.08.2019. The ERC in its 278^{th} meeting held on $16^{th} 18^{th}$ January, 2020 after considered by ERC and the following observation was made:-

(i) List of teaching faculty is not duly approved by the affiliating body as per Appendix-4 of NCTE Regulation, 2014.

- (ii) Land is on the private lease basis, which is not accepted.
- (iii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority is not submitted.
- (iv) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.

- 5. NOW THEREFORE, recognition granted to the institution viz. Parijat Academy Teacher Education Institution, Milan Nagar, 'O' Lane, Dibrugarh, Assam-786003 (APE00298) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from 2020-2021.
- 6. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
