ORDER

WHEREAS, Dr.Anita Baruah Sarma College of Education, Guwahati, Assam – 781024 was granted recognition for B.Ed. course with an intake of 100 from the academic session 2005-2006 vide order dated 20.07.2005, followed by revised order dated 22.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th, 31st May & 01st June'2019 considered the matter and observed as under:
 - i. Show Cause Notice u/s 17(1) were issued on 20.04.2018 & 27.11.2018.
 - ii. No reply received in response to SCN dated 27.11.2018 within the stipulated period.
 - iii. As per approved faculty list, principal and two faculties viz. Monalia Choudhury & Biju Moni Das do not have requisite qualification as per NCTE Norms, hence not qualified.
 - iv. Computer Instructor/Asst. System Manager is not treated as a faculty. Hence, the institution is required to appoint requisite faculty (1 Principal+15 lecturers qualified as per Norms) and submit the same in the NCTE prescribed proforma duly approved by the affiliating body.
 - v. Building plan submitted is not approved by Govt. Engineer.
 - vi. Building completion certificate is not submitted.

In view of the above, the Committee decided as under:-

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing Code No. **APE00326** is **withdrawn** under section 17(1) of NCTE Act; 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to Dr.Anita Baruah Sarma College of Education, Guwahati, Assam – 781024 (Code No. APE00326) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
