<u>ORDER</u>

WHEREAS, St. Xavier's College, P.B. No.9, Purulia Road, Ranchi, Jharkhand-834001 (APE00244) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2005-2006 vide ERC Order No. 3134 dated 29.10.2004, followed by revised order vide No.32752 dated 31.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 271st meeting held on 24th 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:
 - (i) The submitted faculty list is not as per NCTE norms.
 - (ii) The submitted building plan is in small font and not legible. A clear copy of blue print building plan duly approved by competent Govt. Engineer is required to be submitted.
 - (iii) Building completion certificate is not signed by competent Govt. Engineer.
- 3. AND WHEREAS, the ERC in its 274th Meeting held on 15^{th} 16^{th} July, 2019 considered the matter and reply dated 03.06.2019 & 07.06.2019 from the institution in response to Show Cause Notice dated 18.05.2019 and observed as under.
 - > 1st show cause notice u/s 17(1) issued on 21.02.2019 follow by Final show cause notice issued dated 18.05.2019 and the institution is still deficient on the following ground:-
 - (i) Building completion certificate is not signed by Govt. Engineer.
 - (ii) The validity of FDRs expired in April, 2019.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. St. Xavier's College, P.B. No.9, Purulia Road, Ranchi, Jharkhand-834001 (Code No. APE00244) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
