Order

WHEREAS Kartik Oraon College, Palkot Road, Gumla, Jharkhand-835207 (Code No. APE00295) was granted recognition by ERC, NCTE on 21.06.2005 for conducting B.Ed. course of one year duration with an annual intake of 100 from the academic session 2005-2006 subject to fulfilment of the following conditions:

- (i) The institution shall ensure that one HOD and seven faculty members duly qualified as per NCTE norms are in position before the commencement of the B.Ed. course and confirmation to this effect may be sent to the ERC, NCTE within one month from the commencement of the academic session.
- (ii) The institution shall ensure that all teachers are appointed on full time and regular basis as per NCTE norms.
- (iii) The institution shall submit a list of teachers duly counter signed by the competent authority of the affiliating University within one month of the commencement of the course.
- (iv) The institution shall ensure that all the teachers and other staff are paid regular salary as per UGC/State Govt. pay scale and the acquaintance role shall be sent to ERC, NCTE within 3 months from the commencement of the course.
- (v) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- (vi) The institution shall shift to its own premises within three years from the date of recognition.
- (vii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda - Vs - Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hqrs. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-27/2014/NCTE/Insp./A85323 dated 24.03.2014 with the following observations:-

- (i) The institution has not adhered to the prescribed norms by not creating the required instructional facilities.
- (ii) The institution does not fulfill the prescribed norms relating to engagement of staff on regular basis and engagement of regular HOD.

- (iii) The institution has not complied with the requirement of maintaining Endowment fund and Reserve fund of Rs. 5.00 lakhs and Rs. 3.00 lakhs respectively in the form of FDRs jointly with the Regional Director, ERC, Bhubaneswar as stipulated in the recognition order as well as in the NCTE Regulations.

3. AND WHEREAS the applicant institution had not submitted any representation in response to deficiency letter dated 24.03.2014 within the stipulated period to ERC, NCTE. The Eastern Regional Committee in its 172nd Meeting held on 17th June 2014 considered the matter and as decided by ERC, a show cause notice u/s 17(1) to the institution was issued vide No. 26597 dated 30.06.2014 for compliance of the above deficiencies pointed out by NCTE Hqrs.

4. AND WHEREAS the applicant institution had submitted its representation dated 18.07.2014 in response to show cause notice u/s 17(1) dated 30.06.2014 to ERC, NCTE. The Eastern Regional Committee in its 174th Meeting held on 5th August 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) was issued vide No. 26924 dated 13.08.2014 to the institution on the following grounds:-

- (i) The institution has not purchased the items/equipments for Resource centres till date.
- (ii) The institution has not appointed the teaching faculty on regular basis as well as part-time lecturers for Arts, Health & Physical Education and a librarian till date.
- (iii) The institution is required to submit the fresh faculty list duly approved by the Registrar of the concerned university.
- (iv) The institution has not submitted the renewed/converted FDRs of Rs. 5 lakh and Rs. 3 lakh in the joint name of institution and RD, ERC, NCTE, Bhubaneswar.

5. AND WHEREAS the applicant institution submitted its representation dated 27.08.2014 in response to show cause notice u/s 17(1) dated 13.08.2014 to ERC, NCTE. The Eastern Regional Committee in its 175th Meeting held on 9th September 2014 considered the facts on records available in the file, the inspection report of the NCTE Hqrs. as well as the reply submitted by the institution. The matter was discussed in detail and observed that the institution is still having the following deficiencies which are contravened to the Norms and Standards prescribed in the Regulations of NCTE:-

- (i) The institution has not purchased the items/equipments for Resource centres till date.
- (ii) The institution has not appointed the teaching faculty on regular basis as well as part-time lecturers for Arts, Health & Physical Education and a librarian till date.

In view of the above, the committee decided as under:

The Committee concluded that the institution is running the B.Ed. course violating the NCTE Norms and Regulation 2009. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-2016.

6. NOW, THEREFORE, grant of recognition to Kartik Oraon College, Palkot Road, Gumla, Jharkhand-835207 (Code No. APE00295) for B.Ed. course is hereby withdrawn from the academic session 2015-2016 in terms of section 17(1) of NCTE Act, 1993.

7. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days of the issue of the order.
