Order

WHEREAS Jawaharlal Nehru College, Chakradharpur, West Singhbhum, Jharkhand-833102 (Code No. APE00312) was granted recognition by ERC, NCTE on 12.05.2005 for conducting B.Ed. course of one year duration with an annual intake of 100 from the academic session 2005-2006 subject to fulfilment of the following conditions:

- (i) The institution will ensure that one HOD and seven teaching faculty members duly qualified as per NCTE norms are in position before the commencement of the B.Ed. course and a report to this effect shall be sent the ERC within one month from the commencement of the academic session.
- (ii) The institution shall ensure that all teachers are appointed on full time and regular basis.
- (iii) The institution shall submit a list of teachers duly countersigned by the competent authority of the affiliating University within one month from the commencement of the course.
- (iv) The institution shall ensure that all the teachers and other staff are paid salary as per UGC/State Govt. pay scale and the acquaintance roll should be sent to ERC, NCTE within three months from the commencement of the course.
- (v) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- (vi) The institution shall shift to its own premises within three years from the date of recognition.
- (vii) The institution will create Reserve fund equivalent to three month salary of the staff and a confirmation to this effect be sent to this office.
- (viii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulation.
- 2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda Vs Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hqrs. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-63/2014/NCTE/Insp./A86389 dated 30.04.2014 with the following observations:-
- (i) The institution is deficient in respect of both infrastructural and instructional facilities.
- (ii) The institution has violated the prescribed norms relating to the appointment of teaching and non-teaching staff. All the staff members are appointed on a contractual basis for a limited period of less than one year. They are not entitled to the service benefits admissible to regular employees of the University. The HOD is also appointed on contact in the pay scale of a lecturer.

- (iii) The institution does not fulfill the norms of maintaining Reserve fund and Endowment fund in Joint account with Regional Director, ERC.
- 3. AND WHEREAS the applicant institution had submitted its representation dated 06.06.2014 in response to deficiency letter dated 30.04.2014 to ERC, NCTE. The Eastern Regional Committee in its 172nd Meeting held on 17th June 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26522 dated 26.06.2014 on the following grounds:-
 - (i) The institution is deficient in respect of both infrastructural and instructional facilities
 - (ii) The institution has violated the prescribed norms relating to the appointment of teaching and non-teaching staff. All the staff members are appointed on a contractual basis for a limited period of less than one year. They are not entitled to the service benefits admissible to regular employees of the University. The HOD is also appointed on contact basis in the pay scale of a lecturer.
 - (iii) The institution does not fulfill the norms of maintaining Reserve Fund and Endowment fund in joint account with Regional Director, ERC, NCTE.
 - 4. AND WHEREAS the applicant institution had submitted its representations dated 15.07.2014 in response to show cause notice dated 26.06.2014 to ERC, NCTE. The Eastern Regional Committee in its 174th Meeting held on 5th August 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26957 dated 18.08.2014 on the following grounds:-
 - (i) The institution is deficient in respect of both infrastructural and instructional facilities.
 - (ii) The institution has violated the prescribed norms relating to the appointment of teaching and non-teaching staff.
 - (iii) All the staff members are appointed on a contractual basis for a limited period of less than one year.
 - (iv) They are not entitled to the service benefits admissible to regular employees of the University.
 - (v) The HOD is also appointed on contact basis in the pay scale of a lecturer.
 - 5. AND WHEREAS the applicant institution had submitted its representations dated 10.09.2014 in response to show cause notice u/s 17(1) dated 18.08.2014 to ERC, NCTE. The Eastern Regional Committee in its 176th Meeting held on 09.10.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars, as well as the reply submitted by the institution. The matter was discussed in detail and observed that the institution is still having the following deficiencies which are contravened to the Norms and Standards prescribed in the Regulations of NCTE:-
 - (i) The institution is deficient in respect of both infrastructural and instructional facilities.
 - (ii) The institution has violated the prescribed norms relating to the appointment of teaching and non-teaching staff.
 - (iii) All the staff members are appointed on a contractual basis for a limited period of less than one year.

- (iv) They are not entitled to the service benefits admissible to regular employees of the University.
- (v) The HOD is also appointed on contact basis in the pay scale of a lecturer.

In view of the above, the committee decided as under:

The Committee concluded that the institution is running the B.Ed. course violating the NCTE Norms and Regulation 2009. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-2016.

- 6. NOW, THEREFORE, grant of recognition to Jawaharial Nehru College, Chakradharpur, West Singhbhum, Jharkhand-833102 (Code No. APE00312) for B.Ed. course is hereby withdrawn from the academic session 2015-2016 in terms of section 17(1) of NCTE Act, 1993.
- 7. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days of the issue of the order.
