Order

WHEREAS Karim City College, Sakchi, Jamshedpur, Jharkhand-831001 (Code No. APE00356) was granted recognition by ERC, NCTE on 19.07.2005 for conduction B.Ed. course of one year duration with an annual intake of 100 from the academic session 2005-2006 subject to fulfilment of the following conditions:

- (i) The institution will ensure that Principal and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent the Eastern Regional Committee within one month of the commencement of the course.
- (ii) The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
- (iii) The institution shall pay salary to the teaching staff as prescribed by State Govt./UGC.
- (iv) The institution shall within one month of the receipt of recognition order, convert the endowment fund account into a joint account in the form of FDR for a period of not less than 60 months (five years) in a Nationalized Bank to be operated along with an official of the Regional Committee.
- (v) The institution shall create a Reserve fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalized Bank.
- (vi) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda - Vs - Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hqrs. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-51/2014/NCTE/Insp./A86381 dated 30.04.2014 with the following observations:-

- (i) The institution shifted to a new premises without obtaining permission from the ERC, Bhubaneswar in violation of the provision contained in Regulation 8(11) of the NCTE Regulations, 2009.

- (ii) The FDRs are not maintained as per NCTE norms.
- (iii) The institution does not fully meet the Norms for the appointment of staff. A regular HOD, lecturer in Mathematics and full time librarian have not been appointed.

3. AND WHEREAS the applicant institution had submitted its representation dated 28.05.2014 in response to deficiency letter dated 30.04.2014 to ERC, NCTE. The Eastern Regional Committee in its 172nd Meeting held on 17th June 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) was issued vide No. 26521 dated 26.06.2014 to the institution on the following grounds:-

- (i) The institution has not submitted any application for shifting of premises before conducting the special inspection and has shifted the institution in the new premises without getting permission from the ERC, NCTE which is violation of clause 8(11) of the NCTE Regulation.
- (ii) The regular HOD, lecturer in Mathematics and full time Librarian have not been appointed.
- (iii) Original FDRs of Rs. 5.00 lakh and Rs. 3.00 lakh are not submitted towards endowment fund and reserve fund respectively into joint account in the name of institution and RD, ERC, NCTE, Bhubaneswar.

4. AND WHEREAS the applicant institution submitted its reply dated 19.07.2014 in response to show cause notice u/s 17(1) dated 26.06.2014 to ERC, NCTE. The Eastern Regional Committee in its 174th Meeting held on 5th August 2014 considered the facts on records available in the file, the inspection report of the NCTE Hqrs. as well as the reply submitted by the institution. The matter was discussed in detail and observed that the institution is still having the following deficiencies which are contravened to the Norms and Standards prescribed in the Regulations of NCTE:-

- (i) At the time of submission of application dated 28.01.2004 submitted to the ERC, NCTE for recognition of B.Ed. course, the institution had indicated that it was having 5.18 acre of land with a 4-storey building having a built up area of 46,707 Sq. ft. The proposal was to run the proposed B.Ed. course in the existing building of the Karim City College till construction of new building at Mango, Jamshedpur was completed. A resolution dated 27.12.2004 in this regard passed by the college Governing Body was submitted to the ERC. An affidavit dated 27.12.2004 attested by notary stating that infrastructural, instructional and other facilities will be provided as per the NCTE norms, was also submitted to the ERC, NCTE, Bhubaneswar.
- (ii) During special inspection of the institution conducted on 26.09.2013 reveals that the institution is now functioning at Kapali Link Road, Zakir Nagar (W) P.P. Azad Nagar, Jamshedpur and not at Karim City College, Sakchi, Jamshedpur where the recognition for conducting B.Ed. course was granted on 25.07.2005.
- (iii) The Principal, Karim City College has handed over an undertaking dated 26.09.2013 inter-alia, stating that from the session 2013-14 onwards, the B.Ed course has been shifted to the new building and that they will inform the ERC, Bhubaneswar at the earliest.

- (iv) The institution had not submitted any application before conducting the special inspection i.e. upto 26.09.2013.
- (v) Now, the institution submitted its application for shifting of premises on 28.05.2014 along with a DD of Rs. 40,000/- i.e. after the special inspection. The process of all pending file is banned from 3rd March, 2014 as per the direction of the Hon'ble Supreme Court of India.
- (vi) As per the sub-regulation (ii) of Regulation 8 of the NCTE, Regulations 2009, in case of change of premises, prior approval of the Regional Committee concerned after due inspection of the institution at the new site is required.
- (vii) The institution has shifted to a new place without obtaining prior permission of ERC, NCTE, Bhubaneswar in violation of Regulation 8(II) of NCTE Regulation 2009.

In view of the above, the committee decided as under:

The committee concluded that the institution is running the B.Ed. course violating the NCTE Norms and Regulation 2009. The committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-2016.

5. **NOW, THEREFORE, grant of recognition to Karim City College, Sakchi, Jamshedpur, Jharkhand-831001 (Code No. APE00356) for B.Ed. course is hereby withdrawn from the academic session 2015-2016 in terms of section 17(1) of NCTE Act, 1993.**

6. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days of the issue of the order.
