## **ORDER**

WHEREAS, Karim City College, Sakchi, Jamshedpur, Jharkhand-831001 (Code No.APE00356) was granted recognition by ERC, NCTE on 19.07.2005 for conducting B.Ed. Course of one year duration with an annual intake of 100 from the academic session 2005-2006 subject to fulfillment of some conditions mentioned therein.

- AND WHEREAS a Public Interest Litigation vide W.P.(PIL) No.327 of 2011 filed by 2. Shiv Shankar Munda -Vs- Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hars., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hars, issued a deficiency letter to the institution along with the report of deficiencies clarity of the Committee for areater Arora the Prof. vide No.93-51/2014/NCTE/Insp./A86381 dated 30.04.2014 on reasons mentioned therein.
- AND WHEREAS after considering the matter in various meetings, the ERC in its 174th meeting held on 05.08.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars, as well as reply submitted by the institution dated 19.07.2014 in response to ERC's show cause notice U/S 17(1) dated 26.06.2014 and as decided by ERC, withdrawn order was issued to the institution vide No.27007 dated 19.08.2014 from the academic session 2015-2016 in terms of Section 17(1) of NCTE Act 1993 on the following grounds.
  - At the time of submission of application dated 28.01.2004 submitted to the ERC, NCTE for recognition of B.Ed course, the institution had indicated that it was having 5.18 acre of land with a 4-storey building having a built up area of 46,707 sq.ft. The proposal was to run the proposed B.Ed course in the existing building of the Karim city college till consturuction of new building at Mango, Jamshedpur was completed. A resolution dated 27.12.2004 in this regard passed by the college Governing Boday was submitted to the ERC. An affidavit dated 27.12.2004 attested by notary stating that infrastructural, instructional and other facilities will be provided as per the NCTE norms, was also submitted to the ERC, NCTE, Bhubaneswar.

(ii) During special inspection of the institution conducted on 26.09.2013 reveals that the institution is now functioning at Kapali Link Road, Zakir Nagar (W) P.P. Azad Nagar, Jamshedpur and not at Karim City College, Sakchi, Jamshedpur where the recognition for conducting B.Ed. course was granted on 25.07.2005.

(iii) The Principal, Karim City College has handed over an undertaking dated 26.09.2013 inter-alia, stating that from the session 2013-14 onwards, the B.Ed course has been shifted to the new building and that they will inform the ERC, Bhubanesw at the earliest.

(iv) The institution had not submitted any application before conducting the special inspection i.e. upto 26.09.2013.

(v) Now, the institution submitted it application for shifting of premises on 28.05.2014 alongwith a DD of Rs. 40,000/- i.e after the special inspection. The process of all pending file is banned from 3<sup>rd</sup> March, 2014 as per the direction of the Honble Supreme Court of India.

(vi) As per the sub-regulation (ii) of Regulation 8 of the NCTE, Regulations 2009, in case of change of premises, prior approval of the Regional Committee concerned after due

inspection of the institution at the new site is required.

(vii) The institution has shifted to a new place without obtaining prior permission of ERC, NCTE, Bhubaneswar in violation of Regulation 8(II) of NCTE Regulation 2009.

- 4. AND WHEREAS the institution preferred an appeal to the NCTE Hars, against the ERC's order dated 19.08.2014. The Appellate Authority vides order No.89-331/2014-Appeal/13th Meeting-2014/A99901 dt.10.12.2014 remanded back the case to ERC with a direction to conduct an inspection of the new premises at the earliest and take further action as per the Regulations. In the meantime the order of withdrawal shall remain in abeyance.
- 5. AND WHEREAS the ERC in its 179th meeting considered the appeal order dated 10.12.2014 and decided that VT will be constituted as per NCTE Regulation 2014 after receiving the consent/willingness from the institution. In the meantime the order of withdrawal shall remain abeyance. Accordingly, a letter to the institution was issued on 04.02.2015.
- 6. AND WHEREAS the institution submitted the documents for shifting of premises along with inspection fee which was considered by ERC in its 186th meeting and as decided by ERC, inspection letter for shifting of premises to the institution as well as VT Experts were issued on 19.05.2015 and VT conducted on 06.06.2015.
- 6. AND WHEREAS the ERC in its 191st meeting held on 14-15 July 2015 after considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs., VT report, wherein the ERC has decided as under:
  - (i) Recognition of the institution be continued
  - (ii) Shifting of the institution is permitted.
- 7. NOW THEREFORE, the recognition of the institution viz. Karim City College, Sakchi, Jamshedpur, Jharkhand-831001 (Code No.APE00356) for B.Ed. Course is allowed to continue.
