ORDER

WHEREAS, R. S. P. College, Po-Jharia, Dist.-Dhanad, Jharkhand – 828111 (Code No.APE00428) was granted recognition by ERC, NCTE on 14.09.2005 for conducting B.Ed. Course of one year duration with an annual intake of 100 from the academic session 2006-2007 subject to fulfillment of some conditions mentioned therein.

- 2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No.327 of 2011 filed by Shiv Shankar Munda -Vs- Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hars., New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hars, issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-69/2014/NCTE/Insp./A86379 dated 30.04.2014 on reasons mentioned therein.
- 3. AND WHEREAS after considering the matter in various meetings, the ERC in its 176th meeting held on 09.10.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars, as well as reply submitted by the institution dated 27.09.2014 in response to ERC's show cause notice U/S 17(1) dated 18.08.2014 and as decided by ERC, withdrawn order was issued to the institution vide No.27757 dated 12.11.2014 from the academic resession 2015-2016 in terms of Section 17(1) of NCTE/Act-1993 on the following grounds:
 - (i) The plot No., khesra No., total area & built up area etc. not indicated in the submitted building plan.
 - (ii) Books in the library are only 1315 which are less than the required 3000 books as per norms. The institution has not submitted any bills/cash memos in support of purchasing required number of books for the library as NCTE Norms.
 - (iii) The institution has not submitted the faculty list approved by the Registrar of the concerned University showing the appointment on regular basis. The institution has also not submitted the individual appointment letters on regular basis issued to the faculty members along with their educational & professional certificate.
 - (iv) The institution has not submitted original FDRs of Rs. 5 lakh & Rs. 3 lakh till date.
 - 4. AND WHEREAS the institution preferred an appeal to the NCTE Hars, against the ERC's order dated 12.11.2014. The Appellate Authority vides order No.89-09/2015-Appeal/2nd Meeting-2015/3769 dt.05.05.2015 remanded back the case to ERC with a direction to grant 3 months time, from the date of issue of appeal orders to the appellant institutions, to comply with the requirement of the appointment of faculty on full time basis and also fulfill other requirements of NCTE Regulations 2014.
 - 5. AND WHEREAS the ERC in its 188th meeting held on 19-20 May 2015 considered the appeal order dated 05.05.2015 along with original file of the institution and as decided by the ERC, a letter to the institution was issued on 25.05.2015.

- 6. AND WHEREAS the ERC in its 191st meeting held on 14-15 July 2015 considered the letter dated 25.05.2015 received from the Registrar, Vinoba Bhave University as well as letter dated 26.05.2015 from the Director of Higher Education, Government of Jharkahnd committed that all such requirements along with appointment of full time faculty will be complied with as per new Regulation 2014 by 31.10.2015, wherein the ERC has decided as under:
 - (i) Recognition of the institution be continued.
 - (ii) Review the status will be taken up after 31st Oct.2015. Deficiency found if any, will be communicated to the institution, concerned University and State Government for compliance.
 - (iii) If the institution fails to comply the deficiencies, further course of action shall be taken as per norms.
- 7. NOW THEREFORE, the recognition of the institution viz. R. S. P. College, Po-Jharia, Dist.-Dhanad, Jharkhand 828111 (Code No.APE00428) for B.Ed. Course is allowed to continue.
