Order

WHEREAS S.S.L.N.T. Mahila Mahavidyalaya, Luby Circular Road, Hirapur, Dhanbad, Jharkhand - 826001 (Code No. APE00443) was granted recognition by ERC, NCTE on 15.02.2006 for conducting B.Ed. course of one year duration with an annual intake of 100 from the academic session 2006-2007 subject to fulfilment of the following conditions:

- (i) The institution will ensure that Principal and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent the Eastern Regional Committee within one month of the commencement of the course.
- (ii) The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
- (iii) The institution shall pay salary to the teaching staff as prescribed by State Govt./UGC.
- (iv) The institution shall ensure that salary to the teaching staff is paid through account payer cheque.
- (v) The institution shall ensure that lecturers not having M.Ed. should acquire M.Ed. qualification within five years.
- (vi) The institution shall within one month of the receipt of recognition order, convert the endowment fund account into a joint account in the form of FDR for a period of not less than 60 months (five years) in a Nationalized Bank to be operated along with an official of the Regional Committee.
- (vii) The institution shall create a Reserve fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalized
- (viii) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 2. AND WHEREAS a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda Vs Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hars. New Delhi under section 13 of the NCTE Act 1993. Accordingly, the NCTE Hars. issued a deficiency letter to the institution along with the report of the Prof. Arora Committee for greater clarity of the deficiencies vide No. 93-62/2014/NCTE/Insp./A86383 dated 30.04 2014 with the following observations:-
 - (i) The institution is deficient in respect of both infrastructural and instructional facilities.

- (ii) The institution has violated the prescribed norms by not appointing a Regular HOD and teaching staff on full time and regular basis.
- (iii) The institution does not maintain Endowment and Reserve funds in joint account with Regional Director, ERC.
- 3. AND WHEREAS the applicant institution had not submitted any representation in response to deficiency letter dated 30.04.2014 within the stipulated period to ERC, NCTE. The Eastern Regional Committee in its 172nd Meeting held on 17th June 2014 considered the matter and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26512 dated 25.06.2014 for compliance of the above deficiencies pointed out by NCTE Hars.
- 4. AND WHEREAS the applicant institution submitted its representation dated 09.06.2014 in response to deficiency letter dated 30.04.2014 to ERC, NCTE. The Eastern Regional Committee in its 1.73rd Meeting held on 26th June 2014 considered the representation of the institution and found that non of the deficiencies are complied by the institution. As decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26641 dated 03.07.2014.
 - (i) The land and building is not demarcated for the B.Ed. Programme.
 - fill Multipurpose hall is not available in the institution.
 - (iii) There are no Psychology lab, Language learning lab, Art & work experience room, play- ground and the staff room, Principal room and common room, play ground and staff room for B.Ed. course.
 - (iv) Books in the library are only 1006 which is less than the required 3000 books.

 Seating arrangement in the library is not available.
 - (v) Computers in the EI room are not available.
 - (vi) The HOD is not appointed for B.Ed. Programme.
 - (vii) The institution is required to submit a fresh faculty list appointing the faculty on regular basis and duly approved by the Registrar of the concerned University along with their educational/professional certificates.
 - (viii) Original FDRs of Rs. 5.00 lakh and Rs. 3.00 lakh are not submitted towards endowment fund and reserve fund respectively into joint account in the name of institution and RD, ERC, NCTE, Bhubaneswar.
- 5. AND WHEREAS the applicant institution submitted its representation dated 26.07.2014 in response to show cause notice dated 03.07.2014 to ERC, NCTE. The Eastern Regional Committee in its 174th Meeting held on 5th August 2014 considered the representation of the institution and as decided by ERC, Show Cause Notice u/s 17(1) to the institution was issued vide No. 26970 dated 18.08.2014 on the following deficiencies:-
 - (i) The land and building is not demarcated for the B.Ed. Programme.
 - (ii) Multipurpose hall is not available in the institution.
 - (iii) There are no Psychology lab, Language learning lab. Art & work experience room, play-ground, staff room, Principal room and common room, play ground and staff room for B.Ed. course.
 - (iv) Books in the library are only 1006 which is less than the required 3000 books. Seating arrangement in the library is not available.
 - (v) Computers in the ET room are not available.

The HOD is not appointed for B.Ed. Programme. (vi)

- The institution is required to submit a fresh faculty list appointing the faculty on (vii) regular basis and duly approved by the Registrar of the concerned University along with their educational/professional/certificates.
- AND WHEREAS the applicant institution submitted its representations dated 31.08.2014 in response to show cause notice u/s 17(1) dated 18.08.2014 to ERC. NCTE. The Eastern Regional Committee in its 175th Meeting held on 09.09.2014 considered the facts on records available in the file, the inspection report of the NCTE Hars. as well as the reply submitted by the institution. The matter was discussed in detail and observed that the institution is still having the following deficiencies which are contravened to the Norms and Standards prescribed in the Regulations of NCTE:-
 - The land and building is not demarcated for the B.Ed. programme. Multipurpose hall is not available in the institution. There are no Psychology lab, Language learning lab. Art & work experience room, play-ground, staff room, Principal room and common room for B.Ed. course. The new building is under construction and present building is not as per NCTE norms.

Books in the library are only 1006 which is less than the required 3000 books. (ii) . Seating arrangement in the library is not available. The institution has not submitted any bills/cash memos for purchasing of books in the Library.

The institution has not appointed Principal/HOD and other faculty members as well as supporting staff on regular basis as per requirement of NCTE norms.

In view of the above, the committee decided as under-

The Committee concluded that the institution is running the B.Ed. course violating the NCTE Norms and Regulation 2009. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-2016.

- NOW, THEREFORE, grant of recognition to S.S.L.N.T. Mahila Mahavidyalaya, Luby Circular Road, Hirapur, Dhanbad, Jharkhand - 826001 (Code No. APE00443) for B.Ed. course is hereby withdrawn from the academic session 2015-2016 in terms of section 17(1) of NCTE Act, 1993.
- Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.ora within 60 days of the issue of the order.
