WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Tathagat Teachers Training College, Plot No. 498, 500, Village – Jorapipal, P.O. – Kalyanpur, Dhanbad, Jharkhand - 826004 (Formerly: Tathagat Teachers Training College, Ranibandh, Dhaiya, ISM Dhanbad, City Office, Opp. Kamdhenu Petrol Pump, Shastrinagar (W), Dhanbad, Jharkhand – 826001) has applied for grant of recognition for B.Ed. Course (Code No. APE00508) was received by Eastern Regional Committee of NCTE on 31.12.2004.

- 2. AND WHEREAS, as per decision of 60th ERC Meeting, formal recognition order was issued vide no. ERC/7-60.6.7/2005/152-160 dated 08/09/2005 with an intake 100 from the academic session 2005-2006 to the institution, followed by revised order issued on 31/05/2015 as per Regulation, 2014.
- 3. AND WHEREAS, as per decision of 244th ERC Meeting held on 8th 9th October 2017, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide Order No. ER-244.17.4/ APE00508/B.Ed./2017/54728 dated 18/10/2017.
- 4. AND WHEREAS, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-727/E-47583/2017-Appeal/2nd Mtg.-2018/3rd & 5th Feb., 2018/64091 dated 16/03/2018 decided that the impugned order deserved to be set aside and the matter is remanded to ERC with a direction to consider the reply of the appellant, to be sent again to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward all the documents submitted in the appeal to the ERC within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.
- 5. AND WHEREAS, the ERC in its 254th Meeting held on 16th 17th April, 2018 reviewed the matter in accordance with the appeal order and observed that all required documents, as submitted by the institution to the Appellate Authority, have been received.

In view of the above, the Committee decided as under:

Recognition for B.Ed. Course is continued.
