#### **ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Radha Govind Teachers Training College, Behind Ramgarh College, Ramgarh Cantt., Dist. - Hazaribagh, Jharkhand - 829122 has applied for grant of recognition for B.Ed. Course (Code No. APE00722) was received by Eastern Regional Committee of NCTE on 01.08.2001.

- 2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. AND WHEREAS, as per the decision of 71<sup>st</sup> ERC Meeting held on 27<sup>th</sup> 29<sup>th</sup> November, 2006, formal recognition order was issued vide No. ERC/7-71.4.15/2006/4961 dated 15.12.2006 for conducting B.Ed. course with an intake of 100 (One hundred) to the institution.
- 4. AND WHEREAS, a Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda Vs Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993 and Rule 8 of NCTE Rules.

The ERC in its 191<sup>st</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> July, 2015 considered the matter and as decided, a Notice dated 30.07.2015 was issued to the institution on the following ground:

(i) As per the faculty list submitted lecturer in Physical Education, Music are shown part time which is not permissible as per new Regulation 2014. The institution is required to appoint them as regular basis.

Reply in response to ERC's Notice dated 30.07.2015 has not been received till date and the institution is still deficient on the above ground.

#### In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. APE00722 is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session.

5. NOW, THEREFORE, grant of recognition to Radha Govind Teachers Training College, Behind Ramgarh College, Ramgarh Cantt., Dist. - Hazaribagh, Jharkhand - 829122 (Code No. APE00722) for B.Ed. Course vide Order No. ERC-7-71.4.15/2006/4961 dated 15.12.2006 is hereby withdrawn in terms of section 17(1) of NCTE Act, 1993 from the next academic session.
