Dhanbad, Jharkhand-828201 (Code No.ERCAPP1124) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 16589 dated 02.03.2013, followed by revised order vide No.31956 dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 considered the matter and as decided. Show Cause Notice u/s 17(1) was issued on 2. 18.06.2019 to the institution on the following grounds:
  - (i) The submitted faculty list is not clear.
  - (ii) Building plan is not legible.
- AND WHEREAS, the ERC in its 275th Meeting held on 27th July, 2019 considered the matter and reply dated 25.06.2019 from the institution in response to Show Cause Notice dated 18.06.2019 and observed as under.
  - $\triangleright$  1 st show cause notice u/s 17(1) issued on 11.03.2019. Final show cause notice issued dated 18.06.2019 and the institution is still deficient on the following grounds:-
    - (i) Last page of submitted faculty list dated 29.10.2015 showing photocopy of .newspaper, which is not accepted.

(ii) Building plan not authenticated by competent Govt. Authority.

(iii) Building completion certificate is not submitted. Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
