ORDER

WHEREAS, N.N. Ghosh Sanatan Teachers Training College, Plot No.- 165, Vill.- January, P.O.- Kokodro, Tehsil/Taluka Kanke, Town/City-Ranchi, Dist-Ranchi, Jharkhand-834006 (ERCAPP1221) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No. 16578 dated 02.03.2013, followed by revised order vide No. 32502 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 271st meeting held on 24th - 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:

- (i) Validity of original FDRs of Rs. 5 lakh and Rs. 3 lakh have been expired on 15.02.2018 and another original FDR of Rs. 4 lakh is in single mode. Hence, the institution is required to submit FDRs Rs. 5 lakh & Rs. 7 lakh towards endowment and reserve fund in joint operation mode as per NCTE, Regulations, 2014.
- (ii) Building plan is not approved by Govt. Engineer.
- (iii) Building Completion certificate approved by Govt. Engineer in the NCTE prescribed proforma is not submitted.
- (iv) No confirmation of website of the institution.

3. **AND WHEREAS**, the matter was placed before the committee in its 275th ERC meeting held on 27th July, 2019 considered the matter and reply dtd. 04/07/2019 submitted by the institution in response to the SCN dtd. 18.05.2019 and committee took the decision as under:

➤ 21st show cause notice u/s 17(1) issued on 17.12.2018, followed by final show cause notice dated 18.06.2019 and the institution is still deficient on the following grounds:-

- (i) Submitted faculty list not approved by affiliating body duly stamped.
- (ii) Faculty list comprises 1+12 instead of 1+15 as per NCTE Regulations, 2014.
- (iii) Faculties at sl. No.5, 10 & 12 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017

4. **NOW THEREFORE**, recognition granted to the institution viz, **N.N. Ghosh Sanatan Teachers Training College**, Plot No.- 165, Vill.- Jamuary, PO.- Kokodro, Tehsil/TalukaKanke, Town/City-Ranchi, Dist-Ranchi, Jharkhand-834006 (Code No. ERCAPP1221) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

5. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
