### **ORDER**

WHEREAS, Jaspuria B.Ed. College, Plot No. 155, Vill.-Bisa, PO. - Getalsud, Tehsil/TalukaAngara, Town/City - Ranchi, Dist.-Ranchi, Jharkhand - 835103 (Code No. ERCAPP990) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC dated 28.12.2012, followed by revised order dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHERAS**, the ERC in its  $269^{th}$  meeting held on  $02^{nd}$   $03^{rd}$  March, 2019 considered the reply dated 28.10.2015 in response to revised recognition order submitted by the institution along with SCN dated 14.02.2019 and as decided, recognition withdrawn from the academic session 2019-2020 vide order dated 03.03.2019 to the institution.
- 3. **AND WHEREAS**, The institution preferred an appeal to NCTE HQs. and the Appellate Authority vide order No.89-111/E-111207/2019-Appeal/13<sup>th</sup>Mtg.-2019/30<sup>th</sup> April, 2019/79105 dated 03.06.2019 remanded back the case to ERC with the observation that before issuing the impugned order of withdrawal dated 03/03/2019, Regional Committee should have waited for at least such time which was allowed in the SCN. The withdrawal order should also be restricted to the grounds on which SCN was issued. In the current scenario, the impugned withdrawal order is not justified and is set aside. Appellant institution is required to submit written representation to ERC on all grounds mentioned in the SCN as well as impugned order within 15 days of the issue of appeal order. ERC is required to revisit the matter and issue appropriate order afresh.
- 4. **AND WHEREAS**, the ERC re-viewed the matter in accordance with the appeal order as well as documents submitted by the institution vide letter dated 11.06.2019 and decided as under:

"Recognition be restored from the academic session 2019-2020. Accordingly, order be issued to the institution and all concerned".

5. NOW, THEREFORE, recognition granted to the institution viz. Jaspuria B.Ed. College, Plot No. 155, Vill.-Bisa, PO. - Getalsud, Tehsil/Taluka - Angara, Town/City - Ranchi, Dist.-Ranchi, Jharkhand - 835103 (Code No. ERCAPP990) is hereby restored from the academic session 2019-2020 and withdrawal order has been treated as cancelled.
