WHEREAS, Ura College of Teachers Education Kohima, Town/City/P.O-Kohima, Dist-Kohima, Nagaland-797001 (Code No. ERCAPP1206) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order No. ERC/7-164.6.16/NCTE/B.Ed./2013/22081 dated 29.11.2013, followed by revised order vide No. 31826 dated 22.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents. competent
 - concerned the plan building b. Approved
 - c. Approved building completion certificate by the concerned competent
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
 - AND WHEREAS, the ERC in its 263rd Meeting held on 15th 16th November, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) of NCTE Act, 1993 by ERC, NCTE dt. 28.11.2018 on the following grounds:-
 - Faculty list is not in the NCTE prescribed proforma and also not approved by the concerned affiliating body. Qualified faculty as required under NCTE (i) Regulations, 2014 are to be appointed.

Building completion certificate is not in the NCTE prescribed format.

- Validity of FDRs of Rs.5 lakh and Rs.3 lakh expired on 22.09.2016 and not in joint operation mode. The institution is required to submit FDRs of Rs.5 lakh and Rs.7 (ii) (iii) lakh towards EF & RF in joint operation mode as per NCTE Regulations, 2014.
- AND WHEREAS, the institution has submitted reply in response to show cause notice dt. 28.11.2018 received on 18.02.2019. The ERC in its 268th Meeting held on 24th -25th February, 2019 considered the matter and as decided, show cause notice u/s 17(1) issued on 13.03.2019 on the following grounds:-Contd...2

- (i) Submitted faculty list comprising 1+7 (including one part-time) not approved by concerned affiliating body. Faculties comprising 1+15 as per NCTE Regulations, 2014 are required to be appointed.
- (ii) Building completion certificate approved by Govt. Engineer in the NCTE prescribed proforma is not submitted.
- 5. **AND WHEREAS**, the institution has submitted reply vide dt. 19.03.2019 & 10.04.2019 in response to show cause notice dt. 13.03.2019 received in this office on 25.03.2019 & 16.04.2019. The ERC in its 271st meeting held on $24^{th} 25^{th}$ April, 2019 considered the reply and as decided, show cause notice u/s 17(1) issued on 18.05.2019 on the following grounds:-
 - (i) The submitted faculty list is not approved by affiliating body. Requisite number of faculty (1+15) as per NCTE norms not appointed.
- 6. **AND WHEREAS**, the institution has submitted reply dt. 22.06.2019 in response to show cause notice dt. 18.05.2019 received this office on 01.07.2019. The ERC in its 274th meeting held on 15th 16th July, 2019 consider the matter that 1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 18.05.2019 and the institution is still deficient on the following ground:-
 - (i) Faculty list is not signed and approved by concerned affiliating body.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 7. NOW THEREFORE, recognition granted to the institution viz. Ura College of Teachers Education Kohima, Town/City/P.O-Kohima, Dist-Kohima, Nagaland-797001 (Code No. ERCAPP1206) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of such order i.e. from 2020-2021.
- 8. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
