## <u>ORDER</u>

NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act. 1993. the Eastern Regional Committee, NCTE hereby grants recognition/permission MPC Autonomous College, Takhatpur, Barlpada, Plot no-226, 227, 232, 234, 260, 79, Street No-Nou Road, VIII-Takhatpur, Po-Nou Campurs, Takhatpur, Yehsli/Tatuka/Town/City-Barlpada, Dist-Mayurbhanj, Odisha-757003 for conducting 4 yr B.A. B.Sc. B.Ed. Integrated Course of four year duration with an intake 100 (two basic units) from the academic session 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
  - Ine institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
  - III. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- The recognition/permission is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-2017.
- Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable,
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c) Name of faculty members who left or joined during the last quarter;
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application:
  - i) The institution shall be free to post additional relevant information, If it so
  - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
  - The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  - The institution shall make available list of students admitted on its official 9. website.
