Order

In terms of Section 14(1) of the NCTE Act, 1993 DAV Institute of Nursery Teacher Education, Sector-VI, CDA, Bidanasi, Cuttack-753 014, Orissa had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting Nursery Teacher Training Programme of two year duration from the academic session 2004-2005 with an annual intake of 50 (fifty) students.

- 2. The institution requested vide their letter dated 20.11.2004 to consider their application for Pre-School Teacher Education programme on the ground that Orissa Govt. is preparing the curriculum document on pre-school teacher education of one year duration, and not for Nursery Teacher Education of two years duration as given in NCTE norms. The committee, in its 51st meeting held on 30.11.2004 considered their request and decided that their application may be considered for Pre-School Teacher Education programme of one year duration.
- 3. The institution vide its letter dated 17.12.2004 requested to change the name of the institution as DAV institute of Teacher Education instead of DAV institute of Nursery Teacher Education. The Committee considered the request of the institution regarding change of name of the institution and decided that the name may be changed as DAV Institute of Teacher Education (Pre-school).
- 4. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team; the Committee has noted the following:
 - i) The institution has acquired the land for setting up the teacher education institution.
 - The institution has selected 2 (full time) and 2 (part time) teachers for the said course but the institution has not mentioned anything about the Principal/ Head and the list of faculty members have also not been approved by the concerned Directorate/ affiliating body of the State Government.
- 5. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to DAV Institute of Teacher Education (Preschool), Sector-VI, CDA, Bidanasi, Cuttack-753 014, Orissa for Pre-school Teacher Education Programme of one year duration from the academic session 2005-2006 with an annual intake of 50 (fifty) students subject to fulfillment of the following:
 - a) The institution shall ensure that Principal/ Head and two full time and two part-time faculty member duly approved by the affiliating body are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee.
 - b) The examination would be conducted by the examining body as designated by the State Government.
 - c) The institution shall shift to its own building within three years from the date of recognition.
 - d) The institution shall within one month of the receipt of recognition order convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - e) The institution shall maintain reserve fund equivalent to three months salary of the staff as per NCTE norms and a report to this effect shall be sent to the Eastern Regional Committee before the commencement of the course.
 - f) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

- 6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 7. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
