- b. The institution shall pay salary to the teaching staff as prescribed by the concerned Government.
- c. The institution shall obtain affiliation from the examining body before the commencement of the course.
- d. The institution shall maintain and update their website as per NCTE regulations.
- e. The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- f. Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- g. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory body like State Government, wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
