 - The institution will ensure that the teaching faculty members (1(one) Principal/Head + 2 (two) full-time teachers and 2 (two) part-time teachers) duly qualified as per NCTE norms are in position for an intake of 50 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee before the commencement of the course, and information be put up in the institution website as per NCTE regulation 2005, notified in Gazette of India dated 13th January, 2006.

- b) The institution shall pay salary to the teaching staff as prescribed by State Govt./affiliating body through Account Payee Cheque.
- c) The number of administrative staff and technical support staff shall be maintained as per NCTE norms. The qualifications of technical support staff shall be maintained as per norms prescribed by NCTE. The qualifications of the administrative staff shall be maintained as per norms prescribed by NCTE.
- d) The institution shall obtain affiliation from the examining body before the commencement of the course.
- e) The institution shall maintain and update their website as per NCTE regulations.
- f) The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- g) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- h) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government, wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Charted Accountant.
