## Order

In terms of Section 15(1) of the NCTE Act, 1993 Nabakrushna Choudhury College of Teacher Education, Angul, Orissa, Pin – 759 122 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting M.Ed. Course of one year duration from the academic session 2005-2006 with an annual intake of 24 (Twenty four) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:
  - i. The institution has acquired the land for setting up the teacher education institution.
  - ii. The institution has constructed the building for conducting the course on the above mentioned land.
  - iii. The institution have one Principal, one Reader and 10 lecturers in position for both B.Ed. & M.Ed. course whereas as per NCTE norms a Head in the rank of Professor/ or Reader, and three Readers/ Lecturers are required for intake of 25 or less for M.Ed.course. The list of teaching staff submitted by the institution has not been countersigned by the affiliating University.
- 3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Nabakrushna Choudhury College of Teacher Education, Angul, Orissa, Pin 759 122** for **M.Ed.** Course of one year duration from the academic session **2005-2006** for an intake of **25** (twenty five) students subject to fulfillment of the following conditions:
  - a. The institution shall ensure that One Head and 03 (three) Readers/ Lecturers duly qualified as per NCTE norms are in position for an intake of 25 students and the institution shall submit the separate lists of teaching staff for B.Ed. and M.Ed. duly countersigned by the competent authority of the University within one month of commencement of the course.
  - b. The institution shall pay salary to the teaching staff as prescribed by UGC. / State Govt.
  - c. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
