**ORDER**

WHEREAS Kabiguru College of Education, Plot No.-RS3011, 3012,, 3016, 3024, 3025, Vill.-Rahamatpur, PO.- Rahamatpur, Tehsil/Taluka-Tehatta, Town/City-Karimpur, Dist.-Nadia, West Bengal-741165 (ERCAPP1160) was granted recognition for B.Ed. course with an intake of 100 vide ERC Order No. 24417 dated 03/03/2014 for the session 2014-2015, followed by revised order vide No.32285dated 27/05/2015 with an annual intake of,100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> -16<sup>th</sup> February 2020, considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 26/02/2020 to the institution on the following grounds:-

- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit
- (vi) Certified copy of registered land document to be submitted.
- (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.

3. AND WHEREAS, the ERC in its 282<sup>th</sup> Meeting held on 8<sup>th</sup> -9<sup>th</sup> July, 2020, considered the matter along with the reply received from the institution on 17/03/2020 in response to Show Cause Notice dated 26/02/2020 and decided as under :-

- (i) Validity of photocopy FDRs of Rs.5 lakh and Rs.3 lakh has been expired on 27.02.2019.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

4. NOW THEREFORE, recognition granted to the institution viz. Kabiguru College of Education, Plot No.-RS3011, 3012,, 3016, 3024, 3025, Vill.-Rahamatpur, PO.- Rahamatpur, Tehsil/Taluka-Tehatta, Town/City-Karimpur, Dist.-Nadia, West Bengal-741165 (Code No. ERCAPP1160) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

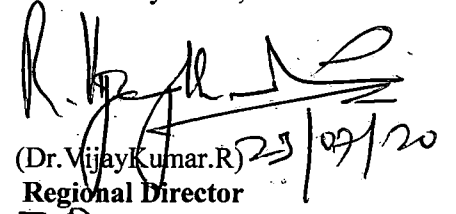

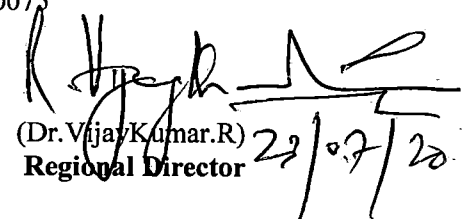
