 - (v) Confirmation on website updates of the institutions with all details along with affidavit
 - (vi) Certified copy of registered land document to be submitted.
 - (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 3. AND WHEREAS, the ERC in its 282th Meeting held on 8th -9th July, 2020, considered the matter along with the reply received from the institution on 17/03/2020 in response to Show Cause Notice dated 26/02/2020 and decided as under:-
 - (i) Validity of photocopy FDRs of Rs.5 lakh and Rs.3 lakh has been expired on 27.02.2019.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.
