WHEREAS recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Jawahar Lal Smarak Post Graduate College, Maharajganj-273303, Uttar Pradesh. vide order No. F.No.F-7/UP-2238/166 Meeting/2010/891-897 dated 29.11.2010 for B.P.Ed. course of one year duration from the academic session 2010-2011 with annual intake

- 2. AND WHEREAS, the matter was placed before NRC in its 325th Meeting held on 08th to 09th January, 2021 and the Committee decided that show cause notice under section 17 of NCTE Act, 1993 be issued to the institution. Accordingly, show cause notice was issued to the institution on 19.01.2021.
- 3. AND WHEREAS, in response to Show Cause Notice Under Section 17 dated 19.01.2021 the institution has submitted a representation received in NRC office on 26.03.2021 without any documentary evidence. Hence, the institution has submitted Affidavit Rs.100 stamp paper 12.02.2021 regarding willingness of NCTE Regulations 2014. the institution has failed to prove that the institution had complied the conditions prescribed under Regulations, 2014 by submitted an affidavit as a willingness in the year 2015.
- 4. AND WHEREAS, the matter was placed before NRC in its 406th (Part-1) Meeting held on 01st to 03rd August, 2023 and the Committee decided that Final Show Cause Notice under section 17 of NCTE Act, 1993 be issued to the institution. Accordingly, Final show cause notice was issued to the institution on 12.08.2023. In response to Final Show Cause Notice reply was submitted by the institution on 01.09.2023.
- 5. AND WHEREAS, as per decision taken by NRC in its 411thMeeting of NRC held on 15th September, 2023 the recognition was withdrawn the recognition for B.P.Ed. course under section 17 of NCTE Act, 1993 from the academic session 2024-2025. Accordingly withdrawal order was issued to the institution vide order F.No.NRC/NCTE/UP-2238/B.P.Ed./411th (Blended Mode) Meeting/2023/223553-223559) dated 07.10.2023.
- 6. AND WHEREAS, the institute preferred an appeal. The appellate authority passed an Order No. File No. 89-214/E-322068/2023 Appeal/15th Meeting, 2023 APPLNRC202314635/123202 dated 19/12/2023 as under: -

I. <u>DECISION: -</u>

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to NRC with a direction to verify the submitted documents filed by the Appellant institution with Appeal from the records available with NRC and if it feel necessary and

appropriate then documents may also be verified from the concerned competent authority. The Appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time in terms of direction given herein above.

7. **AND WHEREAS,** the institution representation was received in NRC office on 28.12.2023 was considered by the NRC in its 418th meeting held on 23rd and 24th January 2024and the committee decided as under:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, Guidelines issued by NCTE from time to time, the NRC after careful consideration made the following observations: -

The institution is running the course under a self-financing scheme and is a grant in aid college and is running B.Ed., B.P.Ed. and M.Ed. Courses. The reply/documents submitted by the institution as directed by the Appeal Committee of NCTE suffers from the following discrepancies.

- i. The institution submitted the proforma of faculty signed by the Registrar, Siddharth University, Kapilvastu, Siddharth Nagar, U.P. vide which only 08 faculty members have been approved for B.P.Ed. course which are not sufficient to run B.P.Ed. course with 1 unit as required under clause 5.1 of Appendix 7 of NCTE Regulations, 2014.
- ii. Further, the institution did not submit the details/approval of 3 Sports Trainers (Part Time), 01 Yoga Trainer (Part Time) and 01 Dietician (Part Time) as required under clause 5.1 of Appendix 7 of NCTE Regulations, 2014.
- iii. The institution is required to submit a copy of the affiliation orders of the last three years with intake capacity issued by the concerned affiliating body for each course being run by the institution/society.

Therefore, the committee decided to issue First Show Cause Notice u/s 17 of NCTE Act, 1993, before withdrawal of the recognition on the grounds mentioned above to the institution. The

institution is required to submit the documents within 30 days from the date of issue of Show Cause Notice."

- **8. AND WHEREAS,** accordingly, first Show Cause Notice was issued to the institution dated 11.05.2024.
- 9. AND WHEREAS, institution has submitted reply on 19.02.2024 received which may in NRC on 27.02.2024 on the basis of uploaded minutes of the NRC website.
- **10. AND WHEREAS,** the matter was placed before NRC in its 423rd Meeting held on 15th July, 2024 and the Committee decided and confirmed as under: -

"The original file of the institution alongwith other related documents, NCTE, Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

• The reply submitted by the institution has been considered by the NRC and the same was found satisfactory. Hence, it has been decided that no further action is required to be taken in the matter and the status of the institution be retained as "recognized" for running B.P.Ed. course with an annual intake of one unit of 100 students.

Letter/ Order be issued accordingly to all concerned.

11. NOW THEREFORE, in terms of above decision of NRC, the recognition granted to the institution viz to **Jawahar Lal Smarak Post Graduate College, Maharajganj-273303, Uttar Pradesh** is hereby restored recognition for B.P.Ed course for one basic units of 100 students until a fresh withdrawal is passed by NRC.
