#### **RESTORATION ORDER**

27 JUN 2074

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Sarvodaya Mahavidyalaya, Post - Chaumuhan, Block Chaumuha, Taluka - Chhata, Town/City - Chaumuhan, District- Mathura, State- Uttar Pradesh-281406 vide order No. NRC/NCTE/ F-3/UP-682/2002/8772 dated 27.11.2002 for 60 seats and an additional intake of one year duration with an annual intake of 40 this making total intake of 100 seats (60 Existing + 40) from the academic session 2009-2010 vide Order No. NRC/NCTE/F-7/UP-2350/Appeal/2010/16981 dated 18.02.2010.

- 2. AND WHEREAS, revised recognition was granted to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. F.NO./NRC/NCTE/NRC/NCTE/UP-2350/2015/111746/81 dated 05.06.2015 with the condition of adherence of provisions of NCTE Regulations, 2014.
- 3. AND WHEREAS, as per decision taken by NRC in its 315<sup>th</sup> (Virtual) meeting the recognition was withdrawn by NRC vide order No. NRC/NCTE/UP-682 & UP-2350/315<sup>th</sup> meeting/2020/209991-96 dated 09.10.2020 from the academic session next following the date of order of withdrawal.
- **4. AND WHEREAS,** the institution filed appeal under section 18 of NCTE Act, 1993 against the withdrawal order 09.10.2020 before the Council and the Appellate Authority had passed order dated 02.09.2021, the operative part of the order is as under:-

"after perusal of the Memoranda of Appeal, affidavit documents on record and submissions madmen during presentation of the appeal case. Appeal Committee of the Council concluded to set aside the impugned order of withdrawal dated 09/10/2020 and remand back the case of Sarvodaya Mahavidyalaya, Chumuhan, 01119, National Highway 2, Chhata, Mathura, Uttar Pradesh to the NRC NCTE for necessary action as indicated above."

- 5. AND WHEREAS, the institution filed Writ Petition No.-10924/2021 in the High Court of New Delhi and Hon'ble High Court passed an order dated 27.09.2021. The operative part of the order is as under: -
  - "3. In these circumstances, the petitioner seeks issuance of an order of restoration of recognition and a direction upon the respondents to permit the petitioner to participate in counselling and admit students for the year 2021-2022.

- 4. The abovementioned facts show that the withdrawal order has already been set aside by the Appellate Committee. As such, until the NRC takes a fresh decision, there is no impediment to the petitioner's recognition and participation in Counselling and admitting students. The NRC is directed to issue an order of recognition within one week from today and to reflect the petitioner's status as a recognised institution on the website within the same period. The NCTE will also communicate the correct status of the petitioner to the affiliating University and the concerned State Government within one week.
- 5. The petition, alongwith pending application, stands disposed of in these terms".
- **6. AND WHEREAS,** in compliance of order dated 27/09/2021. the matter was considered by NRC in its 347<sup>th</sup> (Virtual) Meeting held on 30<sup>th</sup> September, 2021 and the Committee decided as under:

"In the compliance of the order dated 27.09.2021 of the Hon'ble High Court of Delhi at New Delhi vide W.P.(C). 10924/2021 the Committee has considered the matter and took the following decision as per NCTE Act 1992, Rules and Regulation 2014:

- 1. The institution is permitted to participate in the counselling process for admitting the students for the current academic session 2021-22.for 100 students (two units of 50 students each).
- 2. The status of the institution is hereby re-stored and stands Recognized subject to the final decision of the NRC.
- 3. The status of the petitioner- institution as a recognized institution will be reflected on the website and will be communicated to the affiliating University and State Government.

Hence, a letter be issued to the institution as well as concerned authorities i.e. University/affiliating body and State Government of Uttar Pradesh accordingly and website of the NRC be maintained for the Session 2021-22.

The Regional Director of NRC is further directed to place all the orders of appeal committee within 15 days of receiving the order before the NRC positively for further decision the file should again be put before the Committee in next 15 days for taking final decision."

- 7. **AND WHEREAS,** as per decision of NRC in its 365<sup>th</sup> (Blended Mode) (Vol-II) Meeting held on 08<sup>th</sup>& 09<sup>th</sup> March, 2022 the recognition was withdrawn to the institution for B.Ed. course from the end of the academic session 2022-2023 vide order no. NRC/NCTE/NRC/UP-682& UP-2350/365<sup>th</sup> (Part-2) (Blended Mode) meeting/217688-696 dated 24.03.2022.
- **8. AND WHEREAS,** the institution filed appeal under section 18 of NCTE Act, 1993 against the withdrawal order 24.03.2022 before the Council and the Appellate Authority had passed order dated 05.12.2022, vide order No. 89-146/E-257178/2022 Appeal/9<sup>th</sup> Meeting, 2022, that:-

"After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, the committee decided to reject the appeal submitted by the institution and the impugned order passed by the NRC is hereby confirmed."

9. AND WHEREAS, the institution filed W.P.(C) 3118/2023 in the High Court at New Delhi and Hon'ble High Court passed an order dated 20.09.2023 the matter was placed in 413th meeting of NRC held on 29/September/2023 and the committee decided as under operative part of the order.

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC in light of Writ Petition W.P. C 3118 of 2023 before the Hon'ble High Court of Delhi and the Committee decided that the institution is required to submit faculty list approved by the affiliating body along with consolidated list of faculty member signed by the affiliating body."

- 10. AND WHEREAS, institution has submitted reply of letter dated 16/10/2023,19.02.2024 and 14.03.2024 in response to letter dated 11th Oct, 2023.
- 11. AND WHEREAS, the matter was placed before NRC in its 421st Meeting held on 21st and 22nd May 2024, and the Committee decided and confirmed as under: -

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

In response to NRC letter dated 11.10.2023, the reply dated 16.10.2023,19.02.2024 and 14.03.2024 submitted by the institution have been considered by the NRC and the Committee decided to restore recognition to the institution for B.Ed. course for one unit of 50 students from the academic session 2024-25 until a fresh withdrawal order issued by NRC Order be issued accordingly."

12. NOW THEREFORE, in terms of above decision of NRC, the recognition granted to the institution viz to Sarvodaya Mahavidyalaya, Post - Chaumuhan, Block Chaumuha, Taluka -Chhata, Town/City - Chaumuhan, District- Mathura, State- Uttar Pradesh-281406 is hereby restored recognition for B.Ed. course for one unit of 50 students from the academic session 2024-25 until a fresh withdrawal order is issued by NRC
