#### **Closure Order**

WHEREAS, recognition was granted to the institution namely Jaya Prada Institute of Education, Plot/Khasra Number- 3,4, Street Number- Madiyan, Village- Madiyan Udairaj, Post office- Madiyan Udairaj, Tehsil/Taluka- Sadar, Town/City- Rampur, District- Rampur (UP) State- Uttar Pradesh- 261204 for D.El.Ed. programme of two year duration with an annual intake of 50 students from the academic session 2017-18 vide NRC order No. NRC/NCTE/Recognition/ D.El.Ed./2016/146821-7694 dated 02.05.2016.

- 2. AND WHEREAS, the institution submitted a letter No. JIE/147/2024 dated 19.02.2024 has requested for closure of the application D.El.Ed. Course.
- 3. AND WHEREAS, the matter was placed before NRC in its 420<sup>th</sup> Meeting held on 01<sup>st</sup> and 02<sup>nd</sup> April 2024, and the Committee decided as under: -

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

The Committee considered the letter dated 19.02.2024 submitted by the institution requesting closure of the institution for running D.El.Ed. course and the Committee decided to issue the Show Cause Norice to the institution on the following grounds:

- 1. The institution has not submitted the copy of resolution of the Managing society for closure the D.El.Ed. programme.
- 2. The institution has not submitted an affidavit of ₹100/- duly notarized regarding closure of D.El.Ed. programme.

In view of the above, the Committee decided that First Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice."

**4. AND WHEREAS,** the matter was placed before NRC in its 422<sup>nd</sup> (Part-II) Meeting held on 06th and 07<sup>th</sup> June 2024, and the Committee decided as under:

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules. Regulations. SOP. guidelines issued from time to time were placed before the Northem Regional Committee.

The Committee considered the representation dated 31.05.2024 submitted by the institution requesting to close the institution for running D.El.Ed. course and the Committee decided to allow the closure application and to close the institution as requested by the institution by withdrawing the recognition granted to Jaya Prada Institute of Education, Plot/Khasra Number 3,4, Village - Madiyan Udairaj. 1-ehsil Sadar. T'own/City - Rampur. District Rampur (UP), State - Uttar Pradesh - 2612204 for conducting D.El.Ed. course under clause I 7(I) of NCTE Act, 1993 with immediate effect". Order be issued accordingly and the FDRs may also be returned.

- 5. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northen Regional Committee is hereby to allow the closure application and to close the institution as requested by the institution by withdrawing the recognition granted to Jaya Prada Institute of Education, Plot/Khasra Number 3,4, Village Madiyan Udairaj. 1-ehsil Sadar. T'own/City Rampur. District Rampur (UP), State Uttar Pradesh 2612204 for conducting D.El.Ed. course under clause I 7(I) of NCTE Act, 1993 with immediate effect.
- 6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
- 7. As the Recognition of the above institution has been withdrawn by this order, the institution has become defunct and termed as non-existing institution. The institution has been barred to make admissions and function in any manner for the said course.

Since the recognition of the institution has been withdrawn by the NRC, NCTE, the institutions will be allowed to close the FDRs which were maintained in the Joint Account with Regional Director, NRC, NCTE and concerned institution/ Society.

Under the above circumstances, the above said institution is permitted to close the FDRs. NRC, NCTE has no objection if institution wants to close / encash / withdraw the FDRs as detailed below by the duly authorized representative of the respective Management.
