In the Compliance of the order dated 20.12.2021 of the Hon'ble High Court of Delhi at New Delhi vide W.P.(C) 14682/2021 & CM APPL. 46222/2021 the Committee has considered the decision and decided as under:

1. Institution is permitted to participate in the counselling process for admitting student for current session 2021-22 and for all subsequent years until and unless a fresh order of withdrawal is passed against it (for 100 students (Two Units of 50 students each).

2. The withdrawal order will be effective from the end of the academic session 2021-22.

Hence, a letter was issued to the institution as well as concerned authorities i.e. University/affiliating body and State Government of Uttar Pradesh accordingly on 30.12.2021.

The NRC in its 361th (Part-4) Meeting held on 13th to 14th January, 2022 considered the Hon'ble court order and decided as under:

1. In Compliance of the order dated 20.12.2021 of the Hon'ble High Court of Delhi at New Delhi vide Court of Delhi at New Delhi vide W.P. (C) 14682/2021 & CM APPL 46222/2021, the NRC has decided as under:

"As the withdrawal order has been set aside, the NRC is directed to issue a fresh order of restoration of recognition to the petitioner within two weeks and also to update the petitioner's status as a recognized institution on its portal".
