The matter of the Rajiv Gandhi Mahavidyalya,, Village- Pardaha Maunath Bhanjan, mau Post Office-Mau, Tehsil-Maunath Bhanjan, Mau, Uttar Pradesh. Code No. UP-3124, course name B.Ed. Programme was placed before NRC its 341st Emergent Meeting held on 25th August, 2021 and the committee consider the matter and decided as under:

1. Institution is permitted to participate in the counselling process for admitting student for current session 2021-22 for 100 students (Two units of 50 students each).

2. The withdrawal order dated 10.07.2020 will be effective from the end of the academic session 2021-22.

3. Hon'ble Court vide its order dated 28.07.2021 in W.P. © No. 7148/2021 has not quashed the withdrawal order but only allowed institution to admit the student for the current academic year 2021-2022.

The above decision was inadvertently made and again the matter was placed before NRC in its 342<sup>nd</sup> Meeting held on 03<sup>rd</sup> September, 2021 and hereby rectified which should be read as follows:

In the Compliance of the order dated 28.07.2021 of the Hon'ble High Court of Delhi at New Delhi vide W.P.(C) 7148/2021, the Committee has considered the direction of Hon'ble High Court and decided as under:

 Institution is permitted to participate in the counselling process for admitting student for current session 2021-22 for 100 students (Two units of 50 students each).

2. The withdrawal order dated 10.07.2020 passed by NRC is set aside and quashed by the Hon'ble High court at Delhi on 28.07.21. Until a fresh withdrawal order is passed by NRC.

3. Previous letter dated 26.08.21 was inadvertently issued to the petitioner-institution and hence, stands cancelled.

4. The status of the petitioner-institution is restored and hereby stands recognised subject to the issuance of fresh withdrawal order.
