ORDER

WHEREAS, J.S. College of Education, Near Balaji Mandir, Agra Road, Shikohabad, Distt. - Firozabad, (U.P.) has made an application to Northern Regional Committee (for short NRC) seeking permission under section 15(1) of NCTE Act, 1993 to start new course to BTC from academic session 2004-2005.

- AND WHEREAS, after inspection of the institution and taking into consideration the deficiencies pointed out by the inspection team, the NRC in its 84th meeting held on 5-6 October 2004, after providing reasonable opportunity to the institution of making written representation, passed an order refusing permission to the institution for the new course of BTC. In accordance to the decision, NRC issued formal order No. NRC/NCTE/F-3/UP-1492/2003/9798-9806 dated 21.10.2004.
- AND WHEREAS, being aggrieved of the above order, the institution preferred an appeal before the National Council for Teacher Education (for short NCTE) as provided under section 18 of the NCTE Act, 1993 and the NCTE vide order dated 29.04.2005 has reversed the above order of NRC.
- AND THEREFORE, the NRC in its 97th meeting held on 27-28 October 2005 has directed the office to issue order as per directions of the appellate authority. Consequently, the institution namely, J.S. College of Education, Near Balaji Mandir, Agra Road, Shikohabad, Distt. - Firozabad, (U.P.) is hereby grant recognition under section 15(3)(b) of NCTE Act 1993, for an annual intake of 50 seats (Fifty Only) (50 seats in the 1st year and the same for the IInd year in BTC course of two year duration with effect from 28/10/2005 subject to compliance of the following conditions before the commencement of the academic session.
- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ (a) State Govt./SCERT is to be completed before the commencement of the session.

The countersigned statement of all faculty members from the Director, SCERT should (b) be submitted before the commencement of the academic session.

The institution shall adhere to all the other regulations and guidelines as framed by (c) NCTE from time to time.

The institution shall within one month of the receipt of Recognition order, convert the (d) Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.

(e) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.

(f) Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.

(g) Institutions if starts the training programme without prior approval/permission of competent authority/examining body regarding the curriculum they have adopted and conduct of examination for award of Diploma/Certificate the recognition of such institutions shall be withdrawn.

(h) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

- 5. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT/ State Government, etc.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
- 9. Please acknowledge receipt of this order together with its enclosures.
