## RESTORATION ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to, Green Agra Mahavidyalaay, Village- Pali Pokhar, Post Office- Tarrakpur, Avidgarh Road, Etmadpur, District- Agra, State- Uttar Pradesh for B.Ed. course vide order No. NRC/NCTE/F-7/UP-2675/61396-61402 dated 09.09.2008 with an annual intake of 100 seats from the academic session 2008-2009.

- And Whereas, the institution had not submitted an affidavit as its acceptance for adherence to the provisions of the NCTE Regulations, 2014 and therefore, a revised provisional recognition order (RPRO), as per NCTE Regulations, 2014, was issued to the institution vide order No.F.No./NRC/NCTE/UP-2675/2015/101364-69 dt. 20.05.2015 for Annual Intake of 100 students (02 Units) from the academic session 2015-2016.
- AND, WHEREAS, the said recognition was withdrawn by NRC vide order No. NRC/NCTE/UP-2675/315<sup>th</sup> Meeting/2020/209585-90 dated 21.09.2020.
- AND, WHEREAS, the institution filed a W.P. (C) 2591/2021 & CM APPL. 7659/2021 in the Hon'ble High Court Delhi at New Delhi. The Hon'ble Court passed in order dated 20.12.2021. The NRC in its 361th Meeting held on 13th January, 2022 considered the Hon'ble court order and decided as under: -
  - 1. The Hon'ble High Court vide order dated 20.12.2021 order as follows: "As the withdrawal order has been set aside, the NRC is directed to issue a fresh order of restoration of recognition to the petitioner within four weeks and also to update the petitioner's status as a recognized institution on its portal".

In view of the above, the Committee decided as follows:

Restoration of recognition order to the institution is issued and the status of the institution has been updated as a recognized institution on the website of the NRC.
