NCTE Act, 1993, the Regional Committee hereby grants recognition to DARSH COLLEGE OF EDUCATION VPO-KALAN GALUKA-MAHMOODPUR TEHSIL-GOHANA SONEPAT, HARYANA for conducting C.P.ED. course with an annual intake of 50 students, under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-
  - (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
  - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.



Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
