ORDER

WHEREAS, the recognition was granted to the institution namely Sukhmaya Mahavidyalaya, Behra, District Jaunpur-222181, Uttar Pradesh for B.Ed. Course of one year duration with annual intake of 100(One Hundred) students from the academic session 2004-2005 vide order no. F.NRC/NCTE/F-3/UP-1056/3617-3625 dated 08.07.2004.

- AND WHEREAS, the said recognition was withdrawn by NRC vide order dated 26.07.2023. The institution filed an appeal U/s18 of the NCTE Act, 1993 before the Appellate Authority against the withdrawal order.
- AND WHEREAS, the Appellate Authority vide its order dated 31.10.2023 set-aside the withdrawal order dated 26.07.2023 passed by Northern Regional Committee(NRC), NCTE and remanded back the case to NRC.
- AND WHEREAS, the institution has also filed a writ petition bearing no. 11698 of 2024 before the 4. Hon'ble High Court of Delhi and the Hon'ble High Court of Delhi passed order dated 30.08.2024, the operative part of the order is as under:
 - "2. This court is constrained to pass this order since the respondent no.2 i.e. Northern regional Committee('NRC') has failed to decide the order of restoration of recognition of the petitioner though the documents were tendered by the petitioner on 24.11.2023. It is submitted by learned counsel for the petitioner that the counselling will conclude on 20.09.2024.
 - 3. In view thereof, the respondent no.2 is directed to decide the NRC of the petitioner within seven days positively under intimation to the petitioner.
 - 4. This order has been passed in presence of learned counsel for respondent no.2 and therefore is any delay in according the order, the petitioner will be at liberty to approach this court in accordance with law.
 - 5. In view of the above, the present petition along with pending application(s), if any stands disposed of.
 - 6. The order be uploaded on the website forthwith."
- AND WHEREAS, in compliance of the order dated 30.08.2024 passed by the Hon'ble High court of 5. Delhi in W.P.(C) 11698 of 2024 and order dated 31.10.2023 passed by the Appellate Authority, the case was considered by NRC in its 426th (Emergent) meeting held on 06.09.2024 and the following decisions were taken:
- The recognition of the two-year B.Ed. Course be restored with an annual intake of 100 seats. i)
- The list of faculty submitted by the institution be forwarded to the concerned University for ii) verification. The university may also be requested to provide copy of affiliation letter issued to this institution for its B.Ed. course for last three years.

iii) The copy of change of land use, building plan and building completion certificate and fire safety certificate submitted by the institution be forwarded to the concerned department/authority for verification.

NOW THEREFORE, in terms of the above decision of NRC, the recognition of B.Ed. Course for two years duration granted to Sukhmaya Mahavidyalaya, Behra, District Jaunpur-222181, Uttar Pradesh with intake of 100 students (two basic units 50 students each) is hereby restored.
