WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sardar Patel Mahavidyalaya, Fatehpur, Baragaon, Jalalpur, Ambedkar Nagar, Uttar Pradesh for conducting B.Ed. course of one year duration with an annual intake of 100 (One Hundred only) from the academic session 2008-2009 vide Order No. F.NRC/NCTE/F-7/UP-2032/62246 dated 17/09/2008.

- 2. AND WHEREAS, the revised recognition was granted to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. NRC/NCTE/UP-2032/2015/101135-40 dated 20/05/2015.
- 3. AND WHEREAS, the NRC in its 337th meeting (Virtual Mode) held on 08th & 09th July, 2021, the matter was considered and decided to issue Show Cause Notice under section 17 of NCTE Act, 1993 to the institution. Accordingly SCN was issued to the institution on 19/07/2021. The institution has submitted its reply on 31/08/2021.
- 4. **AND WHEREAS,** the reply of the institution was considered by NRC in its 386th meeting held on 23rd November 2022 and decided as under:
- "The original file of the Institution along with other related documents, reply of the institution dated 11/08/2021, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by the NRC and the committee decided that recognition of the institution for B.Ed. programme of two-year duration with an annual intake of two units of 50 students each be continued".
- 5. NOW THEREFORE, this order is issued permitting the institution i.e. Sardar Patel Mahavidyalaya, Fatehpur, Baragaon, Jalalpur, Ambedkar Nagar, Uttar Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (two basic units) of 50 students each subject to fulfilment of the following conditions:
 - (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

(ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

(iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- Name of Students admitted during the current session along with qualification, (d) Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- (e) Fee charged from students;
- (f): Available infrastructural facilities;
- (g)Facilities added during the last quarter;
- Number of books in the library, journals subscribed to and additions, if any, in the last (h) quarter;
- The affidavit with enclosure submitted along with application, (i)
- The institution shall be free to post additional relevant information if it so desires. (j).
- Any false or incomplete information on website shall render the institution liable for (k) withdrawal of recognition. 9.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 16.
- The institution shall fill the information on GIS Portal on the NCTE Website. 11.
