- AND WHEREAS, the matter was placed before NRC in its 415th Meeting held on 20th to 21th November, 2023 and the Committee decided as under :-

" The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:-

The institution has submitted representation dated 11.10.2023 requesting to close the D.El.Ed. course along with resolution of the society and affidavit from the management of Rs. 100/ stamp paper.

The representation dated 11.10.2023 considered in NRC and the committee decided to close/withdraw the recognition of the institution namely Ganga Jamuna Mahavidyalaya, Plot Number - 701, 702, Street/Road - 00, Village/Town/City - Raiganj, Post Office - Raiganj, Tehsil/Taluka - Sadar, Town/City - Gorakhpur, State - UP, District - Gorakhpur (UP), Pin Code -273010 for D.El.Ed. course from the academic session 2024-2025".
