WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely R.P. Post Graduate College, Kamalganj, Farrukhabad, Uttar Pradesh-209724 for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2003-2004 vide order No. F.NO. NRC/NCTE/F-3/UP-765/2003/1902-1909 dated 24.06.2003.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has not consented to come under the Regulations 2014 and affidavit in this regard was also not submitted by the institution. Hence, revised recognition order for B.Ed. two years duration was not issued to the institution.

3. AND WHEREAS, the matter was placed before NRC in its 325th Meeting held on 08th to 09th January, 2021 and the Committee decided as under: -

"Regional Director placed before the committee, a list of 362 such institutions to whom RRO has not been issued till today due to not submission of required affidavit stating that institution and decision of committee.

The committee discussed the matter in depth and decided to issue show cause section 17 to institutions as per list put up before committee for not making compliance to Regulations, 2014."

Accordingly, Show Cause Notice u/17 was issued to the institution vide letter No. F.NRC/NCTE(Item No.107/Minutes of the 325th (Virtual) Meeting/2020/210876-211237 dated 19.01.2021.

4. AND WHEREAS, the institution has not submitted reply of Show Cause Notice under section 17 of NCTE Act 1993 date 19.01.2021. The matter was placed before NRC in its 403rd (Online mode) Meeting held on 13th & 14th July, 2023 and the Committee decided that final show cause under section 17 of NCTE Act, 1993 be issued to institutions to submit reply within 07 days from the date of issue of show cause notice on the following grounds:-

- The revised recognition order was not issued to the institution.

- As per decision of NRC in its 325th meeting the first show cause notice was issued to the institution on 19/01/2021.
- Reply of the First SCN has not been submitted by the institution.

Accordingly, Final Show Cause Notice u/17 was issued to the institution vide letter No. F.No. NRC/NCTE/UP-765/B.Ed./403rd (Online mode) Meeting2023/223873 dated 18.10.2023.

5. **AND WHEREAS**, the institution has submitted reply letter dated 26.10.2023 in response of final show cause notice. The matter was considered in NRC in its 418th Meeting held on 23rd and 24th January 2024 and the Committee decided as under:-

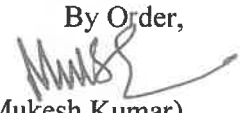
The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the NRC after careful consideration made the following **observations**: -

1. The Revised Provisional Recognition under the NCTE Regulations, 2014 was not issued to the institution as the Affidavit was not submitted by the institution.
2. A first show cause notice dated 19.01.2021 to the institution.
3. The institution did not submit any reply to the first show cause notice dated 19.01.2021.
4. Final Show Cause Notice dated 18.10.2023 was issued to the institution.
5. Reply submitted by the institution against the Final Show Cause Notice vide letter dated 26.10.2023 clearly establishes that the Affidavit was sent to the University instead of NCTE. This was a lapse on the part of the institution.

Hence the **recognition granted to R.P (PostGraduate) College, Kamalaganj, Farrukhabad, Uttar Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 with effect from the academic session 2024 - 2026**. No fresh admissions with effect from the academic session 2024 - 2026 are permitted from now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

6. **NOW THEREFORE**, in view of the above decision of NRC, the NRC hereby **withdraw** the recognition granted to the institution namely **R.P. Post Graduate College, Kamalaganj, Farrukhabad, Uttar Pradesh-209724** for B.Ed. course of one year duration with an annual intake of 100 students with effect from the academic session 2024 - 2026.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website. www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
