RESTORATION ORDER

WHEREAS recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Smt. Prem Lata Maya Devi Agrawal Girls Degree College, Post - Raya, District -Mathura-281204, Uttar Pradeshvide order No. F. NRC/NCTE/F-3/UP-1253/8928-8937 dated 16.08.2005 with an annual intake of 100 seats.

- 2. AND WHEREAS, the revised recognition was granted to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. No./NRC/NCTE/UP-1253/2015/ 112345-51 dated 06.06.2015 with the condition of adherence of provisions of NCTE Regulations, 2014.
- AND WHEREAS, as per decision taken by NRC in its 365th (Part -1) (blended Mode) meeting 3. held on 08th was 19th March, 2022 the recognition was refused by NRC vide order No. NRC/NCTE/UP-1253-B.Ed./365th (Part-1) (Blended Mode) meeting/2022/217882-890 dated 11.04.2022.
- AND WHEREAS, the institution had approached to High court of Delhi at New Delhi in WP (C) 8188/2020, CMAPPs 26516/2020 & 24066/2022 (for interim directions) wherein the High court has passed an order dated 07.10.2022. The operative part of order as under:-
 - "9.1. Withdrawal order dated 10th July 2020, appellate order dated 06th October 2020 and the refusal order dated 11th April, 2022 are set-aside;
 - 9.2. NRC shall re-examine the issue qua the faculty list. They shall be free to conduct a fresh inspection itself or through NCTE, if deemed necessary.
 - 9.3. NRC shall be permitted to seek any information that they may so require from the affiliating university in respect of the faculty members which are mentioned in the list furnished by Petitioner Institute.
 - 9.4. NRC shall thereafter pass an appropriate order, in accordance with law and dispose of the matter, as expeditiously as possible but not later than three months from today.
 - 9.5. Petitioner-Institute shall furnish salary slips of all faculty members before the NRC for last six months, and any other document, if so required, within three weeks from today.

- 9.6. Petitioner-Institute shall be entitled to admit students for B.Ed. in academic session 2022-23 and also for further academic sessions, unless and if a withdrawal order is passed in accordance with law; and
- 9.7. Respondents are directed to update the status of Petitioner-Institute, within a period of one week from the date of uploading the order and send an intimation in respect thereof to the affiliating university of Petitioner as well as to the concerned Department of Education to enable them to participate in counselling and admission process for academic session 2022-23."
- 5. AND WHEREAS, the said court order was considered NRC in its 386^{th (}virtual Mode) meeting held on 23rd November 2022 the Committee considered and decided as under: -
 - "The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC in light of order dated 21/11/2022 passed in Cont. Case No. 1237/2022. The para No. 4 of the order is as follows:
 - "4. It is directed that unless any orders are passed in the proposed LPA which obviate compliance, the respondents shall comply with the direction contained in paragraph 9.7 extracted herein above the ensure that the needful is done in time to enable the petitioner to participate in counselling and admission process for the academic session 2022-2023".

The LPA filed by the NRC was listed for hearing before the bench led by the Hon'ble Chief Justice of Delhi High Court. The learned Counsel appearing for NRC, NCTE has informed about the proceedings of the Hon'ble Court through E-mail on the official mail of legal NRC.

Accordingly, the learned Court was pleased to issue notice in this matter. However, no stay on the impugned order dated 7/10/2022 was granted.

Hence, in view of the above, the NRC decided to allow the institution to participate in the counselling to admit students for the Academic Session 2022-2023.

Further, it is also decided to send and intimation to the Affiliating University and the Department of Education accordingly.

Further, it is also decided that this matter will be put up in the coming meeting for further needful action".

- **6. AND WHEREAS**, in compliance of the decision of NRC in its 386th meeting held on 23rd Sep, 2022, a letter was issued to the institution on 24.11.2022 for permission to participate in counselling for B.Ed Course to admit students for the academic session 2022-2023.
- 7. AND WHEREAS, the institution had filed a petition numbered 1023/2023 and matter was again considered by NRC in its 406th meeting held on 01st to 03rd August, 2023 and decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered

by NRC in light of contempt case 1023/2023 and the Committee decided to allow the petitioner institution to participate in the counselling and admit students for the academic session 2023-2024."

- 8. AND WHEREAS, in compliance of the decision of NRC in its 406th (part-1) meeting (virtual) held on 1st to 3rd August, 2023 a letter was issued to the institution on 14.08.2023 for permitted to participate in counselling for B.Ed Course to admit students for the academic session 2023-2024.
- 9. AND WHEREAS, the institution again filed a contempt (civil) petition No. CONT. CAS(C) 1191/2024 of 2024 in civil petition No. 8188 of 2020 and the matter was again considered NRC in its 424th meeting held on 01st August 2024, and the committee decided as under:

"The Original file of the institution alongwith Appeal Order, other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

- The Committee noted the institution has filed another Contempt Petition in Civil Writ Petition No. 8188/2020 with prayer before the Hon'ble Court to issue notice to the Contemnors Calling upon them as to why the contempt proceedings shall not be initiated against them for having willfully and deliberately disobeying the directions contained in para 9.6 and 9.7 of the order dated 07.10.2022 passed by this Hon'ble Court in W.P. (c) No. 8188 of 2020.
- The Committee, therefore decided to restore recognition of the institution for running two units (100 students) of B.Ed. course until a fresh withdrawal order is passed by the NRC as per NCTE Regulations 2014 and the said restoration will be subject to the outcome of the LPA files by the office of NRC against the order dated 07.10.2022 passed by the Hon'ble Court of Delhi in W.P (c) No. 8188 of 2020."

Order be issued accordingly.

7. NOW THEREFORE, in terms of the above decision of NRC, the recognition granted to the institution viz to Smt. Prem Lata Maya Devi Agrawal Girls Degree College, Post – Raya, District – Mathura-281204, Uttar Pradesh is hereby restored for running two units (100 students) of B.Ed. course until a fresh withdrawal order is passed by the NRC as per NCTE Regulations, 2014 and the said restoration will be subject to the outcome of the LPA No.680/2022 filed by the office of NRC against the order dated 07.10.2022 passed by the Hon'ble Court of Delhi in W.P (c) No. 8188 of 2020."
