The matter of the institution was considered by the NRC in its 318^{th} (Virtual) Meeting (Part-2) held on 19^{th} , 22^{nd} and 28^{th} October, 2020 and the Committee decided as under:

In the Compliance of the order dated 18.09.2020 of the Hon'ble High Court of Delhi at New Delhi vide W.P.(C) 6648/2020 & CM APPL. No. 23152/2020, the Committee has considered the decision and took the following decision as per NCTE Act, 1993, Rules and Regulations, 2014:

- 1. The institution is permitted to give admission to the students for the academic session 2020-2021. The withdrawal order will be effective from the academic session 2021-2022. The institution will not be permitted to admit students from the next academic session 2021-2022 in B.Ed. course.
- 2. In this regard, a letter No. NRC/NCTE/UP-3124-B.Ed./2020/ 209919-24 dated 08.10.2020 has been issued to accept the decision of the Hon'ble High Court of Delhi and subsequently withdraw the same vide letter No. even number/210174-79 dated 16.10.2020, the action taken by Regional Director, NRC is hereby confirmed the letter dated 08.10.2020 as mentioned above.
