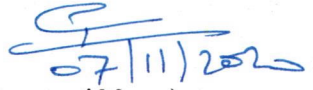

In the Compliance of the order dated 13.10.2020 of the Hon'ble High Court of Delhi at New Delhi vide W.P.(C) 7850/2020, the Committee has considered the decision and took the following decision as per NCTE Act, 1993, Rules and Regulations, 2014:

1. The institution is permitted to give admission to the students for the academic session 2020-2021. The withdrawal order will be effective from the academic session 2021-2022. The institution will not be permitted to admit students from the next academic session 2021-2022 in B.Ed. course.
