WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Shivlok Sadhna Degree, Meharban Singh Ka Purva, Kanpur Nagar, U.P. Pin Code-208001 for B.Ed. course of one year duration with an annual intake of 100 students vide NRC order No.NRC/NCTE/F-7/UP-1683/2008/49097-103 dated 13.05.2008.

- The representation dated 17.10.2023 received from Authorized Signatory, Shivlok Sadhna Degree, Meharban Singh Ka Purva, Kanpur Nagar, U.P. Pin Code-208001 requesting to close the recognition of B.Ed. Course along with Closure application, reason for closure of institution letter, Resolution for closure of institute, NOC of U.P. University, Kanpur and No pendency certificate.
- AND WHEREAS, the matter was considered in NRC in its 416thMeeting held on 20 December 2023 and the Committee decided as under :-

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP and guidelines issued from time to time were placed before the Northern Regional Committee. The NRC made the following decision:-

Consequent upon the request of the institution vide letter dated 16.10.2023 for closure of B.Ed. course, the NRC decided to accept the request for closure of B.Ed. course. Therefore, Order withdrawing recognition under clause 17 of NCTE Act, 1993 be issued to the institution and NOC for releasing the FDRs be issued.

NOW THEREFORE, in view of the above decision of NRC, the NRC hereby close / withdraw the recognition granted to the institution namely Shivlok Sadhna Degree, Meharban Singh Ka Purva, Kanpur Nagar, U.P. Pin Code-208001 for B.Ed. course of one year duration with an annual intake of 100 students.
