ORDER

WHEREAS, the recognition was granted to Sant Kinaram Mahavidyalaya Kaneri Ghazipur, Plot Number – 81, 93, 94KH, Street/Road – NA, Village - Kaneri, Post Office – Kaneri, Tehsil/Taluka - Saidpur, Town/City - Saidpur, District - Ghazipur (UP), State- UP, Pin Code- 233304 for B.Ed. course vide order No. File No./NRC/NCTE/NRCAPP-7541/Recognition/B.Ed./2016/143895-3978 dated 03.03.2016 with an annual intake of 100 students from the academic session 2016-2017.

AND WHEREAS, the recognition was withdrawn by NRC vide order No. File No./NRC/NCTE/NRCAPP-7541/261st Meeting/2016/16544-80 dated 19.01.2016. The institution had filed an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993 against the withdrawal order passed by NRC. The Council (NCTE) remands back the case to NRC vide order No. File No./89-88/2017/Appeal/10th Meeting/2017 dated 21.06.2017.

AND WHEREAS, in light it order dated 21.06.2017 passed by the Council (NCTE), the institution had submitted representation in the office of NRC on 04.07.2017 for restoration the recognition.

AND WHEREAS, the NRC considered the representation submitted by the institution with the appeal order and decided to restore the recognition of the institution for B.Ed. course for 100 students granted vide order dated 03.03.2016.

Now therefore, in terms of decision taken by NRC in its Meeting 272nd held on 06th to 07th July, 2017, the recognition granted to Sant Kinaram Mahavidyalaya Kaneri Ghazipur, Plot Number – 81, 93, 94KH, Street/Road – NA, Village - Kaneri, Post Office – Kaneri, Tehsil/Taluka - Saidpur, Town/City - Saidpur, District - Ghazipur (UP), State- UP, Pin Code- 233304 vide order No. File No./NRC/NCTE/NRCAPP-7541/Recognition/B.Ed./2016/143895-3978 dated 03.03.2016 is hereby restored.
