CONTINUATION ORDER

28 JUN 2023

WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Chaudhary Raghunath Singh Mahavidyalaya, Fatehpur Sikri Road, Kirawali, District – Agra, State – Uttar Pradesh** for conducting B.Ed. Course of one year duration with an annual intake of 100 (One Hundred) vide Order No. F.NRC/NCTE/F-3/UP-1929/10348-10357 dated 26.09.2005.

2. **AND WHEREAS**, The matter was placed before NRC in its 301st Meeting held on 09th to 11th May, 2019 in light of letter No./8214/2019 dated 15.02.2019 received from Dr. B. R. A. University, Agra against the 134 institutions including the above institution alongwith the letter No./7999/2019 dated 19.01.2019 written by the university to the institution and the Committee, decided to issue Show Cause Notice under Section 17 of the NCTE Act, 1993.

Accordingly, First Show Cause Notice U/S 17 (Complaint) was forwarded letter to the institution on 20.06.2019.

3. **AND WHEREAS**, the institution has submitted reply in NRC office on 11.07.2019. The matter was considered by NRC in its 313th Meeting (Part-1) held on 25th to 27th February, 2020 and committee decided that Second show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice on the following grounds :-

1. The institution has not submitted approved faculty list in original with the details of their academic qualifications/ experience etc.
2. The institution has not submitted the details of salary disbursed to the faculty along with six months Bank statement along with account number of each faculty members.
3. The reply of SCN dated 20.06.2019 submitted by the institution is not satisfactory as it does not address the above deficiencies and the institution is being given final opportunity before withdrawal of recognition.
4. Further, the website link showing the faculty details is not submitted by the institution.

Accordingly, Second Show Cause Notice U/S 17 was issued to the institution on 14.09.2020.

4. **AND WHEREAS**, the institution has submitted representation date 02.11.2022 & 01.03.2023 requesting to issue revised Recognition Order in respect of B.P.Ed. course & B.Ed. course. the matter was considered by NRC in its 398th meeting (Blended Mode) held on 09th & 10th May, 2023 and the committee decided as under:

1. The institution has submitted all required documents against to the SCN issued after RPRO.

In view of above, the NRC decided that Recognition Continuation order for B.Ed. course of two years duration (two units of 50 students each total 100 seats) be issued to the institution.

5. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Chaudhary Raghunath Singh Mahavidyalaya, Fatehpur Sikri Road, Kirawali, District – Agra, State – Uttar Pradesh** for continuation of recognition for **B.Ed.** Programme for two-years duration with an annual intake of 100 (**two basic units**) of **50 students each** subject to fulfilment of the following conditions:-

- (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- (a) Sanctioned programme(s) along with annual intake in the institution.
- (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last, quarter:
- (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- (e) Fee charged from students;
- (f) Available infrastructural facilities;
- (g) Facilities added during the last quarter;
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
