WITHDRAWAL ORDER

10 JUL 2023

WHEREAS, the recognition was granted to the institution namely Savita Devi Mahavidyalaya, Delhi Meerut Road, Mohiuddinpur, District- Meerut- 250205, Uttar Pradesh for conducting B.Ed. course of one-year duration with an annual intake of 100 students vide Order No.NRC/NCTE/F-3/UP-1282/2004/7734 dated 16.09.2004 and B.Ed. (Addl.) course of one year duration with an annual intake of 100 seats (Existing 100+ additional 100= 200 students) vide Order No. F.No.NRC/NCTE/F-73/UP-2361/2007/33800-33806 dated 06.12.2007.

2. AND WHEREAS, In light of NCTE Regulations, 2014 revised recognition order was issued to the institution for B.Ed. course for two years duration with annual intake of four units (200 students) from the academic session 2015-2016 vide order No./NRC/NCTE/UP-2361 & UP-1282/B.Ed./2015/100841-846 dated 20.05.2015.

3. AND WHEREAS, as per decisions taken by NRC in its 281st Meeting held on 20th to 21st February, 2018 and the Committee decided to issue Show Cause Notice to all institutions which have not submitted compliance of the revised recognition order.

Accordingly, Show Cause Notice U/s 17 was issued to the institution on 27.03.2018.

4. AND WHEREAS, the institution has not submitted reply of SCN U/s. The matter was considered by NRC in its 317th (Virtual) Meeting held on 22nd to 23rd September, 2020.

Accordingly, Show Cause Notice U/s 17 was issued to the institution on 09.10.2020.

5. AND WHEREAS, the institution has not submitted reply of SCN U/s 17. The matter was considered by NRC in its 322nd (Virtual) Meeting held on 07th December, 2020 and the Committee decided as under: -

The institution has not submitted reply of two consecutive Show Cause Notices issued on 27.03.2018 and subsequently on 19.10.2020 and Committee decided as under:

1. The recognition of B.Ed. & its Additional Intake and M.Ed. courses to be withdrawn from academic session 2021-2022.

Hence, NRC decided to withdraw the recognition of B.Ed. & its Additional Intake and M.Ed. courses under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of communication of withdrawal order i.e. 2021-2022. A detailed withdrawal order be issued to the institution for respective courses.

Accordingly, Withdrawal Order was issued to the institution on 03.03.2021.

6. AND WHEREAS, the institution has filed W.P. (C) 10708/2021 in the Hon'ble High Court Delhi at New Delhi. The order passed by the Hon'ble Court on dated 22.09.2021, was considered by NRC in its 347th (Virtual) Meeting held on 30th September, 2021 and the committee decided as under :



- 1) The NRC in its 322nd meeting held on 7th December, 2020 has taken decision for withdrawal of recognition B.Ed, B.Ed (Addl Intake) and M.Ed courses of the institution and same was uploaded in the Public Domain i.e. on the Website of NCTE on the next day.
- 2) Inadvertently, withdrawal order was issued on 3rd March, 2021.
- 3) It is also pertinent to note that the matter is pending at the level of Appellate Committee and the specific direction by the Hon'ble Court is given to the Appellate Authority to dispose of the petitioners appeal as expeditiously as possible and practicable.

In view of the above, the Committee decided that a Review Petition may be filed against the Hon'ble High Court of Delhi order dated 22.09.2021 at the W.P.(C) 10708/2021 immediately and apprised the Committee in the next meeting.

7. **AND WHEREAS**, the matter was considered by NRC in its 347th (Virtual) Emergent Meeting held on 30th September, 2021 of minutes of the 347th meeting were read and confirmed and the Committee decided as under :

1. The NRC in its 322nd meeting held on 7th December, 2020 has taken a for withdrawal of recognition B.Ed. B.Ed. (Addl. Intake) and M.Ed. courses of the institution and same was uploaded in the Public Domain i.e. on the Website of NCTE on the next day.
2. Inadvertently, withdrawal order was issued on 3rd March, 2021.
3. It is also pertinent to note that the matter is pending at the level of Appellate Committee and the specific direction by the Hon'ble Court is given to the Appellate Authority to dispose of the petitioners appeal as expeditiously as possible and practicable.

In view of the above, the Committee decided that an Appeal Petition may be filed against the Hon'ble High Court of Delhi order dated 22.09.2021 at the W.P.(C) 10708/2021 immediately and apprised the Committee in the next meeting.

8. **AND WHEREAS**, the matter was considered by NRC in its 348th Virtual Meeting held on 12th & 13th October, 2021 and the Committee decided as under: -

The matter was put up in the 347th meeting held on 30th Sep 2021. The committee observed that Mr. Ashutosh Rana advocate appeared before the Hon'ble High Court on behalf of NRC NCTE and according to NRO Mr. Ashutosh Rana is not in Panel of Advocates of NRC NCTE and no instruction/direction has been issued to Mr Ashutosh Rana by NRC in this matter.

Hence, the Committee decided to file an appeal against the Hon'ble High Court order dated 22.09.2021 in this matter.

In view of above the matter should be presented before Committee after the decision of appeal.

9. **AND WHEREAS**, the institution filed WP (C) 10708/2021 in the High Court Delhi at New Delhi. The Hon'ble Court passed in order dated 22.09.2021 along with documents. The matter was considered by NRC in its 350th (Virtual) Meeting held on 22 October, 2021 and the Committee decided as under : -

1. Withdrawal order was issued to the institution on 03.03.2021.

In the Compliance of the order dated 22.09.2021 of the Hon'ble High Court of Delhi at New Delhi, the NRC has considered the decision and decided as under:

1. The institution is permitted to participate in the counselling process for admitting the 200 students (four basic units of 50 students each) for the year 2021-22 and for unless a fresh withdrawal order is passed against it.
2. The status of the institution is hereby re-stored and stands Recognised subject to the final decision of the NRC.



3. The status of the petitioner- institution as recognized institution will be reflected on the website and will be communicated to the affiliating University and State Government.

Hence, a letter be issued to the institution as well as concerned authorities i.e. University /affiliating body and State Government of Uttar Pradesh accordingly and website of the NRC be maintained for the year 2021-22 and for subsequent years until and unless a fresh withdrawal order is passed against it.

RD NRC is directed to put the matter before committee within 15 days of receiving of remand order of appeal committee.

Accordingly, letter was issued to the Principal Secretary, Department of Higher Education, Government of Uttar Pradesh, Secretariat, Lucknow- 226001, Uttar Pradesh, the Registrar, C.C.S. University, Meerut, Uttar Pradesh & Savit Devi Mahavidyalay, Delhi meerut Road, Mohiuddingpur, District- 250205, Uttar Pradesh on 22.10.2021.

The institute preferred an appeal. The appellate authority passed an order dated 26.05.2022 Appeal Committee of the Council concluded that the case is deserved to be remanded back to the NRC with direction to consider the submitted reply/documents to be sent them to NCTE Hqrs by appellant and take further appropriate action as per NCTE Regulation 2014.

10. **AND WHEREAS**, the matter was considered by NRC in its 387th Emergent Meeting (Virtual Mode) held on 02nd December, 2022 and the Committee decided that Show Cause Notice U/S 17 be issued to the institution on the following points: -

1. The institution be asked submit the reply to the SCN issued on dated 09.10.2020 within 15 days from the issue of the letter to the institution.

Accordingly, Show Cause Notice issued to the institution on 08.12.2022. The institution has submitted reply of Show Cause Notice vide letter dated 21.12.2022 along with documents received in NRC office on 23.12.2022.

11. **AND WHEREAS**, the matter was considered in NRC in its 390th (Blended Mode) held on 20th and 23rd January, 2023 and the committee decided that Show Cause Notice U/s 17 be issued to the institution on the following points:-

1. The institution is required to submit latest faculty list duly approved by the affiliating body on the specified format of NRC. (Format uploaded on the website of NRC)
2. The institution in reply to Show Cause Notice has submitted that it is running at Khasra No. 639 and had submitted the documents for Khasra No. 639, whereas the recognition for additional intake was granted to the institution at Khasra No. 642 and 645. The institution has shifted to the new premises without approval from NRC.
3. In reply to SCN, the institution has mentioned that it is running the institution at Khasra No. 639 and has submitted the CLU and other documents for Khasra No. 639, whereas the Building plan and Site Plan makes a mention of Khasra No. 639 and 492/1. The institution is required to clarify this discrepancy.
4. The Certificate to the effect that the building is disabled friendly has been issued by Private Architect, which is not acceptable. The institution is required to submit the same issued by Government Engineer.
5. The Building Completion Certificate has been signed by Private Architect and countersigned by Sarpanch. It is required to submit the same approved by Government Engineer.
6. The document submitted in support of Fire Safety Certificate is not a Fire Safety Certificate. It is required to submit a Certificate from the Competent authority that the building of the institution is compliant to the fire safety norms of the State Government.



Accordingly, Show Cause Notice U/S 17 was issued to the institution on 03.02.2023.

The institution has not submitted reply of SCN dt. 03.02.2023 till dated.

12. **AND WHEREAS**, the matter was placed before NRC in its 401st Meeting held on 27th June, 2018. The Committee decided as follows: -

“The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

As per decision of NRC in its 390th meeting held on 20th & 23rd January 2023 the SCN Under Section 17 of NCTE Act, 1993 was issued to the institution on 03/02/2023 on the following grounds:

1. The institution is required to submit latest faculty list duly approved by the affiliating body on the specified format of NRC. (Format uploaded on the website of NRC)
2. The institution in reply to Show Cause Notice has submitted that it is running at Khasra No. 639 and had submitted the documents for Khasra No. 639, whereas the recognition for additional intake was granted to the institution at Khasra No. 642 and 645. The institution has shifted to the new premises without approval from NRC.
3. In reply to SCN, the institution has mentioned that it is running the institution at Khasra No. 639 and has submitted the CLU and other documents for Khasra No. 639, whereas the Building plan and Site Plan makes a mention of Khasra No. 639 and 492/1. The institution is required to clarify this discrepancy.
4. The Certificate to the effect that the building is disabled friendly has been issued by Private Architect, which is not acceptable. The institution is required to submit the same issued by Government Engineer.
5. The Building Completion Certificate has been signed by Private Architect and countersigned by Sarpanch. It is required to submit the same approved by Government Engineer.
6. The document submitted in support of Fire Safety Certificate is not a Fire Safety Certificate. It is required to submit a Certificate from the Competent authority that the building of the institution is compliant to the fire safety norms of the State Government.

Further, the institution has also not submit land use certificate issued by the competent authority and details of salary disbursement through Bank and Downloaded copies of document from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations 2014.

The institution has not submitted reply of Show Cause Notice dated 03/02/2023 till date.

Hence, the committee decided to withdraw the recognition of B.Ed. & B.Ed. additional intake under section 17 of NCTE Act, 1993 from the academic session 2023-2024.”

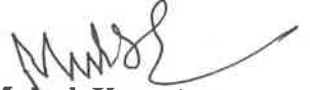
NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **Savita Devi Mahavidyalaya, Delhi Meerut Road, Mohiuddinpur, District- Meerut- 250205, Uttar Pradesh** granted for **B.Ed. course for an intake of 100 Seats & B.Ed. (Addl.) course annual additional intake of 100**(Existing 100 + additional 100= 200 students) on the grounds mentioned above from the end of the academic session next following the date of communication of withdrawal order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org

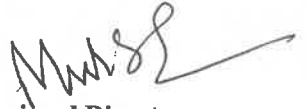
