- AND WHEREAS, the institution H.L.M. College, 11th K.M. Stone, Delhi Meerut Road, Ghaziabad-201001, State - Uttar Pradesh has by affidavit consented to come under New Regulations and sought for one basic unit in
- AND WHEREAS, it has been decided to permit the institution to have one basic unit of 40 students subject to M.P.Ed., which require additional facilities. the institution fulfilling following conditions namely.
- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required (i)
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional (ii) facilities before May 30th, 2015.
