Course under section 17 of the NCTE Act, 1993. Accordingly, Withdrawal Order was issued to the institution vide Orde No.-NRC/NCTE/NRCAPP-2832/337th Meeting/2021/214664-69 dated 16.07.2021 from the next academic session 2022-2023.
- The Institution filed a W.P.(C) 11289/2022 & CM APPL. 33180/2022 in the Hon'ble High Court of Delhi. The Hon'ble High Court passed an order dated 18.08.2022. The NRC in its 376th Meeting (Blended Mode) held on 12th September, 2022 considered the Court Order dated 18.08.2022 and the Committee decided as under:

The institution filed W.P. (C) 11289/2022 & CM APPL 33180/2022 in the High Court of Delhi. The Hon'ble Court order dated 18/08/2022 was considered by NRC in its 376th meeting held on 12/09/2022 and the Northern Regional Committee decided that the withdrawal order will take effect from the end
