Course under section 17 of the NCTE Act, 1993. Accordingly, Withdrawal Order was issued to the institution vide Orde No.-NRC/NCTE/NRCAPP-3508/337th Meeting/2021/214826-31 dated 19.07.2021 from the next academic session 2022-2023.
- 3 The Institution filed a W.P.(C) 10579/2022 & CM APPL. 30628/2022 in the Hon'ble High Court of Delhi. The Hon'ble High Court passed an order dated 18.08.2022. The NRC in its 376^{th} Meeting (Blended Mode) held on 12^{th} September, 2022 considered the Court Order dated 18.08.2022 and the Committee decided as under:

The institution filed W.P. (C) 10579/2022 & CM APPL 30628/2022 in the High Court of Delhi. The Hon'ble Court order dated 18/08/2022 was considered by NRC in its 376th meeting held on 12/09/2022 and the Northern Regional Committee decided that the withdrawal order will take effect from the end of academic session 2022-2023 and the petitioner institution would be
