Sub:- Compliance of decision of NRC in its 372nd Emergent Meeting (Blended Mode) Meeting held on 27th July 2022.

Sir/Madam,

WHEREAS, recognition was granted by the Northern Regional Committee to L.T.R Institute of Technology, Village- Kurali, Baghpat Road, District- Meerut, State- Uttar Pradesh for B.Ed. course vide Order No. NRC/NCTE/F-3/UP-1153/1806-1814 dated 25.05.2005 with an annual intake of 100 seats and in light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-1153/2015/103483-88 dated 23.05.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 students each was issued to the institution with certain conditions.

- **WHEREAS**, the matter was considered by NRC in its 337th (Virtual) Meeting held on 08th & 09th July, 2021 and the Committee decided to withdraw the recognition of B.Ed. Course under section 17 of the NCTE Act, 1993. Accordingly, Withdrawal Order was issued to the institution vide Orde No.-NRC/NCTE/UP-1153/337th Meeting/2021/214614-19 dated 16.07.2021.
- The Institution has filed W.P.(C) 10869/2022 & CM APPL. 31648/2022 in the Hon'ble High Court of Delhi. The Hon'ble High Court passed an order dated 20.07.2022. The NRC in its 372nd Emergent Meeting (Blended Mode) Meeting held on 27th July 2022 considered the Court Order dated 20.07.2022 and the Committee decided as under:

As per the decision of NRC in its 337th meeting withdrawal order was issued to the institution vide dated 16th July 2021 from the next academic session 2022-23.

The NRC also noted that the appellate authority vide order dated 12/07/2022 has confirm the order of withdrawal issued by NRC dated 16/07/2021 but the institution mislead the Hon'ble Court about this confirmation of withdrawal and created impression that the appeal is pending.

The Standing Counsel of NCTE also gave his consent to this fact without taking any instructions/confirmation from NCTE.

The matter was considered by NRC in light of directions dated 20/07/2022 of Hon'ble High Court of Delhi in W.P. (C) No. 10869/2022 and decided that the withdrawal order issued by NRC vide dated 16/07/2021 will take effect from the end of the academic session next following the date of communication of withdrawal order.

- In view of the above decision of NRC, the withdrawal order dated 16.07.2021 para 6 read as " NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of L.T.R Institute of Technology, Village- Kurali, Baghpat Road, District- Meerut, State- Uttar Pradesh granted for B.Ed. course for an intake of 100 seats (two units of 50 student each) vide order dated 25/05/2005 and Revised Recognition Order dated 23.05.2015 on the grounds mentioned above from the end of the academic session next following the date of communication of withdrawal order.
- Other contents of the order No. NRC/NCTE/UP-1153/337th Meeting/ 2021/214614-19 dated 16.07.2021 shall remain unchanged.
